RIDER AP - MOVE ASCENSION ROAD PROJECTS RIDER

APPLICABILITY: This Rider is appliable to electric service furnished under all rates of the Cooperative.

RATE ADJUSTMENT: The sum of \$5.55 shall be added to each monthly bill for Cooperative members receiving electric service in Ascension Parish.

TERMS AND CONDITIONS: This Rider shall be applied for a period of four (4) years beginning on the date established by the LPSC Order issued in Docket No. U-37343 and on such terms and conditions established by the Order.
