#### ARTICLES OF ORGANIZATION OF GDE TIGER DRILLING, LLC

The undersigned, Ted M. Anthony, acting parsuant to La. R.S. 12:1301, et seq., adopts the following Articles of Organization:

#### 1. Name

The name of this limited liability company will be GDE Tiger Drilling, LLC (hereinafter the "Company").

#### 2. Purpose

The purpose of the Company will be to engage in any lawful activity for which limited liability companies may be formed under the Limited Liability Company Law of Louisiana, as amended, including, but not limited to, the purchase, acquisition, holding, mortgaging, and selling of real estate and all forms of immovable property.

#### 3. Certifying Officials

Unless and until an amendment to these Articles of Organization is filed in the office of the Louisiana Scoretary of State, any person dealing with the Company may rely upon a certificate by Gregory D. Elliot to establish the membership of any member, the authenticity of any record of the Company, or the authority of any person to act on behalf of the Company, including, but not limited to the authority to take actions referred in La. R.S. 12:1318(B).

#### 4. Management

The Company will be managed by a Manager or Managers who may, but who are not required to be members. The initial Manager will be Gregory D. Elliott. Certain restrictions on the authority of the Manager and limitations on the authority of the Members to bind the Company may be contained in a written Operating Agreement. Nothing contained berein is intended to limit the rights of third parties to rely on certificates delivered by certifying officials of the Company as set forth in Article 3.

Subject to such limitations as may be imposed pursuant to the terms of this Agreement or by operation of law, and until an amendment to these Articles of Organization providing to the contrary is filed in the office of the Louisiana Secretary of State, the Manager is hereby authorized and empowered to carry out and implement any and all of the purposes of the Company. In that connection, the powers of the Manager will include, but not be limited to, the authority to, either individually or collectively:

a. Engage, on such terms as the Manager deems acceptable in his sole discretion, independent attorneys, architects, surveyors, engineers, accountants, or such other persons as may be deemed necessary or advisable, and to execute contracts, letters or agreements evidencing such terms;

b. Take or approve all actions with respect to distributions by the Company or dispositions of the assets of the Company and execute all such documents as the Manager decens acceptable, in his sole discretion, in order to effectuate such distributions or dispositions of assets;

c. Borrow funds and execute promissory notes and loan agreements evidencing the Company's obligation to repay such funds, in such amounts and on such terms and conditions as the Manager decros acceptable in his sole discretion;

d. Mostgage immovable property owned by the Company, including leasehold interests owned as tenant or as assignee or sublessee under any lease, and improvements to said immovable property, under a conventional mortgage, a collateral mortgage or a future advance mortgage, or to any homestead association, bank or other entity under a vendor's lien and in accordance with the rules and regulations of the bomestead association or bank or other entity, for such amounts and on such terms and conditions as the Manager may deem acceptable in its sole discretion, with such security interests being granted as collateral security for the repayment of the indebtadness and obligations of the Company and/or the indebtedness and obligations of any person, firm, corporation, partnership or other entity to any bank, savings and loan association or any other creditor or other entity whatsoever;

e. Grant security interests in any property owned by the Company, both movable and immovable, tangible and intangible, pursuant to security agreements and other instruments granting security interests in the Company's assets, as collateral security for the indebtedoess and obligations of the Company and/or the indebtedness and obligations of any person, firm, corporation, partnership or other entity to any bank, savings and loan association or any other creditor or other entity whatsoever;

f. Guarantee payment of the promissory notes, mortgage notes, collateral mortgage notes, hand notes or any other indebtedness or obligations of any person, firm, corporation, partnership or other entity to any bank, savings and loan association or any other oreditor or other entity whatsoever;

g. In the case of a homestead association loan, sell the immovable property involved to the homestead association and repurchase same, and to subscribe to any mortgage installment stock as may be necessary, all in accordance with the rules and regulations of said homestead association:

h. Contract for the construction, repair and/or maintenance of buildings and other improvements to immovable property and to execute all such documents as may be necessary with respect to same including without limitation thereto payment and performance bonds, with the terms and conditions of such contracts and the dollar amounts to which the Company is obligated under such contracts being whatever terms and conditions, and such amounts, as the Manager may approve, in his sole discretion;

i. Purchase and/or lease (as tenant) immovable property, and/or other interests in real estate including without limitation thereto easements and servindes, in the State of Louislana, or elsewhere, for such amount or for such rental, and on such other terms and conditions, as the Manager deems acceptable in his sole discretion;

j. Sell and/or lease (as landlord) immovable property, and/or other interests in real estate including without limitation thereto easements and servitudes, in the State of Louisiana, or elsewhere, for such amount or for such rental, and on such other terms and conditions, as the Manager deems acceptable in his sole discretion, and to receive and receipt for the selling price, and to give full acquittance and discharge therefor;

k. Open, maintain, and close bank accounts and draw checks and other orders for the payment of money;

I. Take such other actions and incur such expenses on behalf of the Company as may be necessary or advisable in connection with the conduct of the affairs of the Company; and

m. Execute all documents (including without limitation thereto contracts, agreements, letters, cash salas, deeds, leases, assignments of leases, subleases, mortgages, security agreements, finanoing statements, promissory notes, pledge agreements, mortgages, deeds of trust, mortgage notes, collateral mortgage notes, hand notes, bonds, guaranties, loan agreements, assignments of leases and rents, building

construction contracts and acts of subordination) deemed necessary and reasonable by the Manager in order to implement and put into effect declaions and actions taken by the said Manager pursuant to this Article 4, such documents to contain such terms and provisions as the Manager deems acceptable, in his/her sole discretion, with specific approval for the said Manager to include, but without limitation thereto, provisions in any security instruments executed a waiver of appraisement, a confession of judgment, authority for use of executory process, a non-allenation provision and the usual Louisiana security clauses found in security agreements executed in Louisiana.

The intent of this Article 4 is to place full anthority with each Manager to transact completely the business of the Company as outlined in these Articles, in accordance with its objects and purposes as set forth herein, all without the necessity of the adoption of a separate article or resolution to cover each transaction, or to cover each sale, purchase or mortgage, or the construction of any improvements on the property owned or leased by the Company.

The Manager will have the right to appoint a subagent to represent the Company. This sub-agent will have full authority to act as if named and appointed by this Article 4. The power to act as attorney and agent-in-fact contained in this Article 4 is coupled with the interest of the Members of ensuring that third parties may deal with the above-named agents, without fear of revocation or recission of authority, and therefore the grant contained in this article is interocable unless and until an amendment by authentic act is recorded in the office of the Secretary of State.

Notwithstanding the foregoing, the Managers will not have the authority to, without the consent of the Mambers holding a majority of the percentage interest ownership in the Company (i) sell, exchange, lease, mortgage, pledge or transfer all or substantially all of the assets of the Company; (ii) merge the Company or allow the Company to be a party to an exchange or acquisition of the type described in Sections 1357-1362 of the Louisiana Limited Liability Company Law; (iii) utilize Company assets in any way for the furtherance of personal activities or activities unrelated to the Company's business; (iv) dissolve the Company; (v) commission any act which would make it impossible for the Company to carry on its ordinary business, or (vī) amend the Articles of Organization of the Company.

#### 5. Indemnity

(1) The Company will defend, indemnify and hold harmless an individual made a party to a proceeding because he/she is or was a member, manager, officer, organizer, employee or agent of the Company against liability incurred in the proceeding, if he/she:

- (a) Conducted himself in good faith;
- (b) Reasonably believed that his/her conduct was in or at least not opposed to the Company's best interest; and
- (c) In the case of any criminal proceeding, had no reasonable cause to believe his/her conduct was unlawful.

(2) The Company will pay for or reimburse the reasonable expenses incurred by a member, officer, manager, organizer, employee or agent of the Company who is a party to a proceeding in advance of final disposition of the proceeding, if:

(a) The individual furnishes the Company a written affirmation of his/her good faith belief that he/she has met the standard of conduct described herein;

......

- (b) The individual finnishes the Company a written undertaking executed personally or on his/her behalf to repay the advance if it is ultimately determined that he/she did not meet the standard of conduct; and
- (c) A determination is made that the facts then known to those making the determination would not preclude indemnification under the law.

The undertaking required by this paragraph will be an unlimited general obligation, but need not be secured and may be accepted without reference to financial ability to make repayment.

(3) The indemnification and advance of expenses authorized herein will not be exclusive to any other rights to which any member, manager, officer, organizer, employee or agent may be entitled under any by-law, agreement, vote of disinterested members or otherwise. These Articles of Organization will not be interpreted to limit in any manner the indemnification or right to advancement for expenses of an individual who would otherwise be entitled thereto. These Articles of Organization will be interpreted as mandating indemnification and advancement of expenses to the maximum extent permitted by law.

(4) In addition to the foregoing, the Company will indemnify and save the organizers hamless for all acts taken by them as organizers of the Company and will pay all costs and expenses incurred by or imposed upon them as a result of the same, including compensation based upon the usual charges for any time expenditures required of them in pursuit of the defense against any liability arising on the account of acting as organizers or arising on the account enforcing the indemnification right hereunder, and the Company releases them from all liability for any such act as organizers not involving willful or grossly negligent misconduct.
