1.

This proceeding was initiated when Jefferson Davis Electric Cooperative, Inc. and NextEra Energy Marketing, LLC, filed a Joint Application for Approval of Power Supply Agreement. Notice of this matter was published in the LPSC Official Bulletin Number 1252, dated August 20, 2021. Interventions are due on or before September 7, 2021, considering that Monday, September 6, 2021 is the Labor Day holiday.

Cleco Cajun is a wholly-owned subsidiary of Cleco Corporate Holdings LLC, with its principal offices located at 2030 Donahue Ferry Road, Pineville, Louisiana 71360.

Rule 10 of the LPSC Rules of Practice and Procedures provides that any party actually in interest may appear in any proceeding before the LPSC.

No other party to this proceeding is suited to adequately represent Cleco Cajun’s interests. Accordingly, Cleco Cajun seeks to intervene and participate in this docket as a full party intervenor.

This intervention will not prejudice any other party or unduly delay the proceedings with respect to the examination of the issues presented by this proceeding.



**WHEREFORE**, Cleco Cajun hereby intervenes in this proceeding and requests that it be placed on the LPSC official service list of this docket.


