**PETITION FOR INTERVENTION**

NOW BEFORE THIS COMMISSION, through undersigned counsel, comes Entergy Louisiana, LLC ("ELL" or the "Company"), which, pursuant to Rule 10 of the Rules of Practice and Procedure ("Rules") of the Louisiana Public Service Commission ("LPSC" or the "Commission"), respectfully submits this Petition for Intervention in connection with the above-captioned proceeding. In support of this Petition for Intervention, ELL represents the following:

**I.**

Southern Spirit Transmission LLC initiated this docket by filing their Application on February 14, 2023. Notice of the docket appeared in the Commission's Official Bulletin No. 1291 dated February 17, 2023. Pursuant to Rule 19 of the Rules, interventions are to be filed on or before March 14, 2023. This intervention is, therefore, timely.

**II.**

Pursuant to Rule 10 of the LPSC's Rules, "[a]ny party actually in interest may appear in any proceeding before the" LPSC.

### III.

The Company is a regulated utility that was organized for the purposes, among others, of developing, manufacturing, generating, transmitting, distributing, and selling electricity for power, lighting, heating and other such uses. The Company conducts business in fifty-eight (58) of the sixty-four (64) parishes of the State of Louisiana.

### IV.

This docket pertains to possible construction of a high voltage direct current transmission facility that may be interconnected with the Company's transmission system. The Company, therefore, has a real and substantial interest in this proceeding.

### V.

The Company's interests in this proceeding cannot be represented or protected adequately by any other parties. The Company therefore wishes to participate in this docket as an intervenor.
