- General Order dated April 25, 2012 by engaging in activities related to transporting
- passengers intrastate without LPSC authority. Would the parties present please
- make your appearances, starting with the Commission Staff?
- 19 MR. JUSTIN BELLO: Thank you, Your Honor. Justin Bello on behalf of
- 20 Commission Staff.
- 21 **JUDGE FREY:** And you, sir?
- 22 MR. SYLVESTER FLEMING: Sylvester Fleming on behalf of Sk8tXpress.

- 1 **JUDGE FREY:** Thank you. And how does the Staff plan to move forward this

- 19 Mr. Bello, you've indicated previously that you plan to move forward with this
- 20 matter this morning.
- 21 **MR. BELLO:** That's correct, Your Honor.
- 22 **JUDGE FREY:** You may proceed.

- 1 **MR. BELLO:** Your Honor, Commission Staff is prepared to prove through both
- 2 documentary and testimonial evidence that the carrier cited in this docket, Tru
- 3 Enterprise Corporation dba Car Crusher Inc of Louisiana, which, Your Honor, we'll
- 4 just call Tru Enterprise going forward, violated the Commission rules and
- 5 regulations for failing to maintain the required insurance coverage on file pursuant
- 6 to the General Order dated October 13, 2023. Your Honor, as a result of this
- 7 violation, at the conclusion of the hearing, Commission Staff is going to request
- 8 that the carrier be found guilty of the cited violation, that their Certificate Number
- 9 8516 be cancelled, and that a citation fee be assessed to the carrier. Your Honor,
- at this time we'd like to call our one and only witness, Ms. Tammy Burl.
- 11 Tammy Burl came forth as a witness; and, after having been duly sworn,
- 12 **testified as follows:**
- 13 **DIRECT EXAMINATION BY MR. JUSTIN BELLO**
- 14 **JUDGE FREY:** Thank you, Mr. Bello. You may proceed.
- 15 **MR. BELLO:** Thank you, Your Honor. Good morning, Ms. Burl. How are you
- 16 doing today?
- 17 **MS. BURL:** Good morning. Good.
- 18 **MR. BELLO:** Can you please state your name and business address for the record?
- 19 **MS. BURL:** Tammy Burl, 602 North 5th Street, Baton Rouge, Louisiana 70821.
- 20 **MR. BELLO:** And by whom are you employed?
- 21 **MS. BURL:** The Louisiana Public Service Commission.
- 22 MR. BELLO: And what is your title with the Louisiana Public Service
- 23 Commission?

- 1 **MS. BURL:** I am the Transportation Administrator.
- 2 MR. BELLO: Could you tell us what some of your job duties are as the
- 3 Transportation Administrator?
- 4 **MS. BURL:** Yes. I oversee the day-to-day operations of the division for the motor
- 5 carriers that we regulate, such as towing companies, household good movers,
- 6 passenger carriers, and waste carriers.
- 7 MR. BELLO: Okay. Could you tell us what some of the requirements that the
- 8 Commission has for these regulated carriers, certain things that have to be on file?
- 9 **MS. BURL:** Yes. Carriers are required to maintain insurance on file, renew their
- vehicles every year annually, file annual reports, in addition to other filings.
- 11 MR. BELLO: And as the Transportation Administrator, are you the ultimate
- overseer of all of those filings?
- 13 **MS. BURL:** Yes.
- 14 MR. BELLO: Ms. Burl, could you tell us what documents are submitted by
- 15 regulated carriers to evidence insurance?
- 16 **MS. BURL:** A Form E for their auto liability insurance.
- 17 **MR. BELLO:** And could you tell us what Commission order requires the carries
- 18 file that Form E as proof of insurance?
- 19 **MS. BURL:** The October 13, 2023 General Order.
- 20 **MR. BELLO:** Ms. Burl, how would the Commission be notified of a cancellation
- 21 of a carrier's insurance?
- 22 **MS. BURL:** The underwriter submits a Form K.

- 1 **MR. BELLO:** And again, as part of your job duties that you discussed, you're not
- 2 the direct person who receive those, but you're ultimately responsible for those?
- 3 **MS. BURL:** Correct.
- 4 MR. BELLO: Okay. Ms. Burl, are you familiar with the carrier cited in this
- 5 docket, Tru Enterprise Corporation dba Car Crushers Inc of Louisiana, which we'll
- 6 just call Tru Enterprise from here on out?
- 7 **MS. BURL:** Yes.
- 8 **MR. BELLO:** Is this company registered with the Public Service Commission?
- 9 **MS. BURL:** Yes, they are.
- 10 **MR. BELLO:** Could you tell us what type of carrier this company is?
- 11 **MS. BURL:** They are a towing company.
- 12 MR. BELLO: And has the Transportation Division of the Commission received
- any correspondence associated with this carrier's insurance?
- 14 **MS. BURL:** Yes. We received a Form K.
- 15 **MR. BELLO:** Ms. Burl, you have a document in front of you that's been marked
- 16 for identification as Staff Exhibit 1. Do you recognize this document?
- 17 **MS. BURL:** Yes. This is the Form K that was received by the Commission.
- 18 **MR. BELLO:** Okay. And just to confirm, the Transportation Division did receive
- 19 that document?
- 20 **MS. BURL:** Yes. It was received on January 29, 2024.
- 21 **MR. BELLO:** Okay. And who sent this document to the Transportation Division?
- 22 **MS. BURL:** It was sent to us by -- bear with me, I got to get my bearings on this
- Form E -- Blue Hill Specialty Insurance Company.

- 1 MR. BELLO: Thank you, Ms. Burl. Up at the top right of the document, it
- 2 indicates the checked type cancelled BI and PD. Could you just inform the tribunal
- 3 what BI and PD indicate?
- 4 **MS. BURL:** That is bodily injury and property damage.
- 5 **MR. BELLO:** And again, if you could, and if I already asked this, I apologize.
- 6 Just tell us what this document indicates about the carrier's BI and PD insurance
- 7 policies.
- 8 MS. BURL: It indicates that Tru Enterprises' insurance would cancel effective
- 9 March 6, 2024.
- 10 **MR. BELLO:** And to the best of your information, does this document appear to
- be electronically signed by a representative of the insurance company?
- 12 **MS. BURL:** Yes.
- 13 **MR. BELLO:** And that would be at the bottom right of the text there where it says
- signature of insurer?
- 15 **MS. BURL:** That's correct.
- 16 MR. BELLO: Your Honor, in connection with that testimony, I'd like to offer,
- 17 file, and introduce into evidence Staff Exhibit 1, which is a copy of a Form K
- 18 received by Commission Staff from Blue Hill Specialty Insurance Company.
- 19 **JUDGE FREY:** Staff Exhibit 1 is admitted.
- 20 MR. BELLO: Thank you, Your Honor. Ms. Burl, after the Form K that we just
- 21 introduced into the evidence was received, what did the Transportation section of
- the Commission do next?
- 23 **MS. BURL:** We issued a notice of cancellation letter to Tru Enterprise.

- **MR. BELLO:** Ms. Burl, you have a document in front of you that's been marked
- 2 for identification as Staff Exhibit 2. Do you recognize this document?
- **MS. BURL:** Yes.
- **MR. BELLO:** And what is this document?
- **MS. BURL:** This is a copy of the notice of cancellation letter.
- **MR. BELLO:** And to whom was this letter sent?
- **MS. BURL:** Tru Enterprise Corporation Car Crushers Inc of Louisiana.
- **MR. BELLO:** And what date did the Commission send this document?
- **MS. BURL:** March 15, 2024.
- 10 MR. BELLO: Could you please inform the tribunal what does this document
- 11 indicate?
- **MS. BURL:** It informs the motor carrier that we were in receipt of a cancellation
- notice on their policy and that it cancelled on March 6, 2024, that they were to cease
- operations immediately, and that they need to make the required replacement filing.
- **MR. BELLO:** And you just somewhat mentioned, but I'll ask you to elaborate.
- Did the document provide instructions on how to remedy this insurance issue?
- **MS. BURL:** Yes.
- **MR. BELLO:** And what does it say?
- **MS. BURL:** It should say that they should contact their insurance company and
- 20 have them file the required form with our office.
- **MR. BELLO:** Thank you, Ms. Burl. And, again, you may have indicated this, but
- 22 the document also asks that they cease and desist all operations, correct?
- **MS. BURL:** Correct.

- 1 **MR. BELLO:** Regulated operations, I should say.
- 2 **MS. BURL:** Correct.
- 3 MR. BELLO: Did the letter provide any consequences if the carrier failed to
- 4 provide the proof of insurance?
- 5 **MS. BURL:** Yes. That the Commission would proceed to institute against them a
- 6 citation for cancellation of their authority.
- 7 **MR. BELLO:** Thank you, Ms. Burl. And if you could, up at the top left of this
- 8 letter, does it indicate an address for Tru Enterprise Corporation?
- 9 MS. BURL: Yes. That is 10301 Old Gentilly Road, New Orleans, Louisiana
- 10 70127.
- 11 **MR. BELLO:** And to best of your understanding, is this the same address that the
- 12 Commission maintains on file for this carrier?
- 13 **MS. BURL:** Yes.
- 14 **MR. BELLO:** And since this letter was issued, have you been or are you aware of
- any notice of address change received from the carrier?
- 16 **MS. BURL:** No, they have not changed their address.
- 17 **MR. BELLO:** Ms. Burl, did you prepare this notice of cancellation letter for
- 18 mailing?
- 19 **MS. BURL:** No, it was prepared by my previous employee, Mr. Paul Amy.
- 20 MR. BELLO: And so while you didn't personally prepare this letter, is it your
- 21 understanding that, based on the records that you maintain, that the letter was
- prepared and mailed?
- 23 **MS. BURL:** Yes.

- 1 **MR. BELLO:** Could you tell us whose signature this is at the bottom of this letter?
- 2 **MS. BURL:** This is my signature.
- 3 **MR. BELLO:** Is that automatically generated by the Commission's database?
- 4 **MS. BURL:** Yes, it is.
- 5 MR. BELLO: Thank you. Your Honor, in connection with that testimony, I'd
- 6 like to offer, file, and introduce into evidence Staff Exhibit 2, which is a copy of
- 7 the notice of cancellation letter sent to Tru Enterprise Corporation on March 15,
- 8 2024.
- 9 **JUDGE FREY:** Staff Exhibit 2 is admitted.
- 10 MR. BELLO: Thank you, Your Honor. So Ms. Burl, after this notice of
- cancellation letter was sent, did the carrier submit a Form E or proof of insurance?
- 12 **MS. BURL:** They did not.
- 13 **MR. BELLO:** So what did the Commission do after that failure to provide proof
- of insurance?
- 15 **MS. BURL:** Staff proceeded to issue a tentative hearing letter to the carrier.
- 16 **MR. BELLO:** Ms. Burl, you have a document in front of you that's been marked
- 17 for identification as Staff Exhibit 3, in globo. Do you recognize this document?
- 18 **MS. BURL:** Yes. This is the tentative hearing letter sent to Tru Enterprise.
- 19 **MR. BELLO:** Okay. And could you tell us what this document indicates?
- 20 **MS. BURL:** It notifies them that we had received a Form K, that we had mailed
- 21 them a notice of cancelation letter on March 15th for that cancelation on March 6th,
- and that they had a deadline of May 1, 2024 to make the filing, or they had
- 23 tentatively been scheduled for a hearing today, Thursday, July 11, 2024.

- 1 **MR. BELLO:** Thank you, Ms. Burl. Did you personally prepare this letter?
- 2 **MS. BURL:** No, this was prepared by my previous Staff member, Mr. Paul Amy.
- 3 **MR. BELLO:** But again, as the ultimate records maintainer for the Transportation
- 4 section, is it your understanding that this document was, in fact, prepared and
- 5 mailed to the carrier?
- 6 **MS. BURL:** Yes.
- 7 **MR. BELLO:** Could you please tell us what the address is indicated up at the top-
- 8 left corner of this letter?
- 9 **MS. BURL:** 10301 Old Gentilly Road, New Orleans, Louisiana 70127.
- 10 MR. BELLO: Does that address, again, match with what's on file with the
- 11 Commission?
- 12 **MS. BURL:** Yes.
- 13 MR. BELLO: And if you didn't indicate this, I apologize. If you did -- is this
- letter dated -- well, what is this letter dated?
- 15 **MS. BURL:** April 15, 2024.
- 16 MR. BELLO: And again, you already indicated that it was mailed by the
- 17 Commission; is that correct?
- 18 **MS. BURL:** Correct.
- 19 **MR. BELLO:** Do you happen to know when it would've been mailed?
- 20 **MS. BURL:** On the day that it was prepared, April 15, 2024.
- 21 **MR. BELLO:** And whose signature is on that April 15th tentative hearing letter?
- 22 **MS. BURL:** Mr. Paul Amy.

- **MR. BELLO:** And just to be clear, you're not here certifying to the validity of his
- 2 signature, just to the fact that it's your understanding, as Transportation
- 3 Administrator, the document was prepared and mailed, correct?
- **MS. BURL:** Correct.
- **MR. BELLO:** Is it a standard practice for a Transportation Enforcement Agent to
- 6 email a letter like this to the carrier?
- **MS. BURL:** Yes.
- **MR. BELLO:** Okay. Do you know if this letter was actually mailed to the carrier?
- **MS. BURL:** I am unable to confirm whether Mr. Amy actually emailed it or not.
- 10 MR. BELLO: But again, it's your understanding that it's standard practice for
- such things to be emailed?
- **MS. BURL:** Yes.
- **MR. BELLO:** And what is the email we have on this letter for the cited carrier?
- **MS. BURL:** Carcrusher85@gmail.com
- **MR. BELLO:** Ms. Burl, were there any documents attached to this letter?
- **MS. BURL:** Yes. The notice of cancellation letter, dated March 15, 2024.
- 17 MR. BELLO: Thank you, Ms. Burl. Your Honor, in connection with that
- 18 testimony, I'd like to offer, file, and introduce into evidence the tentative hearing
- 19 letter dated April 15, 2024, that was mailed to the cited carrier.
- **JUDGE FREY:** Staff Exhibit 3 is admitted.
- **MR. BELLO:** Thank you, Your Honor.
- **JUDGE FREY:** In globo.
- **MR. BELLO:** Thank you.

- 1 **JUDGE FREY:** And, sorry, just to confirm, is this an in globo exhibit with the
- 2 notice of cancellation letter attached?
- 3 **MR. BELLO:** It is, Your Honor.
- 4 **JUDGE FREY:** Staff Exhibit 3, in globo, is admitted.
- 5 MR. BELLO: Thank you, Judge. Ms. Burl, after this notice of cancellation -- or,
- 6 excuse me, tentative hearing letter was mailed, are you aware of -- did the USPS
- 7 return this mail in any way to the Commission?
- 8 **MS. BURL:** They did not.
- 9 MR. BELLO: And, again, after the tentative hearing letter was sent to the carrier,
- 10 did the carrier submit a Form E indicating proof of insurance?
- 11 **MS. BURL:** No.
- 12 MR. BELLO: And so after not receiving that information, what did the
- 13 Commission Staff do next?
- 14 **MS. BURL:** We proceeded to issue a citation to the carrier.
- 15 **MR. BELLO:** Ms. Burl, you have a document in front of you that's been marked
- 16 for identification as Staff Exhibit 4, in globo. Do you recognize this document?
- 17 **MS. BURL:** Yes. This is the citation issued to Tru Enterprise Corporation dba
- 18 Car Crushers Inc of Louisiana.
- 19 **MR. BELLO:** And according to the second page of this document, what date did
- 20 the Commission send the document to the cited carrier?
- 21 **MS. BURL:** It was mailed out on May 22, 2024.

- 1 MR. BELLO: And if you could go back to the first page, is the carrier address
- 2 indicated on this document the same as the address on file with the Commission,
- 3 which you have previously identified?
- 4 **MS. BURL:** Yes.
- 5 **MR. BELLO:** Could you tell us whose signature is on this citation on Page 2?
- 6 **MS. BURL:** That is my signature.
- 7 **MR. BELLO:** Ms. Burl, are you aware of any documents that were attached to
- 8 this citation?
- 9 **MS. BURL:** Yes. The tentative hearing letter, dated April 15, 2024, as well as the
- notice of cancellation letter, dated March 15, 2024.
- 11 **MR. BELLO:** And those would be the same two letters that were just previously
- introduced into evidence as Exhibit 2 and Exhibit 3, in globo?
- 13 **MS. BURL:** Correct.
- 14 **MR. BELLO:** Did the citation provide the carrier notice that a citation fee in the
- amount of \$25 had been assessed to the carrier's account?
- 16 **MS. BURL:** Yes.
- 17 **MR. BELLO:** And did the citation also provide the carrier notice that an order
- may be issued by the Commission cancelling the carrier's common carrier
- 19 certificate for failure to maintain the required insurance coverage?
- 20 **MS. BURL:** Yes.
- 21 **MR. BELLO:** Could you tell us what hearing date was provided in the citation?
- 22 **MS. BURL:** Today, Thursday, July 11, 2024, at 9:30 A.M.
- 23 **MR. BELLO:** And that would be at 602 North 5th Street?

- 1 **MS. BURL:** Yes. To be held here at the 11th Floor, at 602 North 5th Street in Baton
- 2 Rouge.
- 3 MR. BELLO: Thank you, Ms. Burl. And was this notice of citation, excuse me,
- 4 published in the Commission's Bulletin?
- 5 **MS. BURL:** Yes. It was published on May 24, 2024.
- 6 MR. BELLO: Your Honor, in connection with that testimony, I'd like to offer,
- 7 file, and introduce into evidence Staff Exhibit 4, in globo, which is a copy of the
- 8 citation issued to Tru Enterprise Corporation in this docket, with attachments.
- 9 **JUDGE FREY:** Staff Exhibit 4, in globo, is admitted.
- 10 MR. BELLO: Thank you, Your Honor. And Ms. Burl, was this citation mailed
- 11 to the carrier?
- 12 **MS. BURL:** Yes. It was mailed by regular mail and certified mail.
- 13 MR. BELLO: Thank you. And to your understanding, was the regular mail
- 14 returned?
- 15 **MS. BURL:** No, it was not.
- 16 **MR. BELLO:** And was the citation claimed?
- 17 **MS. BURL:** Yes, it was.
- 18 **MR. BELLO:** Ms. Burl, you have a document in front of you that's been marked
- 19 for identification as Staff Exhibit 5. Do you recognize this document?
- 20 **MS. BURL:** Yes. This is a copy of the green card in reference to this docket.
- 21 **MR. BELLO:** And on the copy, is the address indicated on the green card the
- same as the address maintained on file for the cited carrier?
- 23 MS. BURL: Yes.

- 1 **MR. BELLO:** Does this document indicate any delivery date?
- 2 **MS. BURL:** It appears that it was signed for by B. Ballard on 5/25/2024.
- 3 MR. BELLO: Thank you, Ms. Burl. And could you confirm that the tracking
- 4 number indicated on this green card ending in 0333, does it match the tracking
- 5 number that's also indicated on the citation that was introduced into the record as
- 6 Staff Exhibit 4, in globo?
- 7 **MS. BURL:** Yes, they match.
- 8 **MR. BELLO:** Is there a docket number indicated on the green card?
- 9 **MS. BURL:** Yes. I placed the Docket Number T-37199 on the green card as a
- 10 reference of where it goes when it comes back to the Commission.
- 11 **MR. BELLO:** Thank you, Ms. Burl. And what date did the Commission receive
- this card back?
- 13 **MS. BURL:** It is kind of light, but I'm going to say June 18, 2024.
- 14 **MR. BELLO:** If you were able to look at the original that's at the Judge's desk,
- would you might be able to see it a little better?
- 16 **MS. BURL:** Yes. Yes, that is June 13, 2024.
- 17 MR. BELLO: June 13th, thank you. Your Honor, in connection with that
- 18 testimony, I'd like to offer, file, and introduce into evidence Staff Exhibit 5, which
- is a copy of the front and back of the green card relative to the certified mailing of
- 20 the citation in this docket. Your Honor, I would note, as we just indicated, that the
- 21 original is before you for inspection.

- 1 **JUDGE FREY:** Thank you. I have what has been offered as Staff Exhibit 5 in
- 2 front of me as well as the original certified mail receipt, and confirm that a copy
- 3 offered by Staff Exhibit 5 matches the front and back. Staff Exhibit 5 is admitted.
- 4 **MR. BELLO:** Thank you, Your Honor. Ms. Burl, as of today, has a representative
- 5 of the carrier filed the appropriate documents to close its certificate?
- 6 **MS. BURL:** No, they have not.
- 7 **MR. BELLO:** And as of today, has the carrier filed proof of insurance or a Form
- 8 E with the Commission?
- 9 **MS. BURL:** No, they have not.
- 10 **MR. BELLO:** Is Staff seeking that the carrier be found guilty of failing to maintain
- insurance filings on file with the Commission for Common Carrier Certificate
- 12 Number 8516 and that that certificate be cancelled?
- 13 **MS. BURL:** Yes.
- 14 **MR. BELLO:** Is the Staff also seeking that a \$25 citation fee be assessed, pursuant
- to the June 7, 2006 General Order?
- 16 **MS. BURL:** Yes.
- 17 **MR. BELLO:** Your Honor, I have no further questions.
- 18 **JUDGE FREY:** Thank you. I just have a few clarifying questions, Ms. Burl. Do
- 19 you have the notice of cancellation letter in front of you that was admitted as Staff
- 20 Exhibit 2?
- 21 **MS. BURL:** Yes.
- 22 **JUDGE FREY:** Do you recall how this letter was mailed to the carrier?
- 23 **MS. BURL:** It was mailed by regular U.S. mail.

- **JUDGE FREY:** Thank you. And do you have the tentative hearing letter in front
- 2 of you that was part of Staff Exhibit 3, in globo?
- **MS. BURL:** Yes.
- **JUDGE FREY:** And do you recall how that was sent in the mail?
- **MS. BURL:** Yes. By USPS postal mail.
- **JUDGE FREY:** All right. And Mr. Amy, the Enforcement Agent, you testified
- 7 that it's his signature on the letter. Who was Mr. Amy, Ms. Burl?
- **MS. BURL:** He is my previous employee who handled all of the insurance filings
- 9 for the Commission.
- **JUDGE FREY:** And he was under your supervision?
- **MS. BURL:** Yes.
- **JUDGE FREY:** And he's no longer employed with the Commission?
- **MS. BURL:** That is correct.
- **JUDGE FREY:** Thank you. And did the citation that was admitted as Staff
- Exhibit 4, in globo, provide a time for the hearing today?
- **MS. BURL:** Yes, 9:30 A.M.
- **JUDGE FREY:** Thank you. And do you have what was admitted as Staff Exhibit
- 18 5 in front of you, Ms. Burl?
- 19 MS. BURL: Yes, ma'am.
- **JUDGE FREY:** I believe you indicated that it was signed. Does there appear to
- 21 be a signature in the complete this section on delivery section, and also a printed
- 22 name?
- **MS. BURL:** Yes.

- JUDGE FREY: Thank you. That's all the questions I have for Ms. Burl. Do you
- 2 have any follow up, Mr. Bello?
- 3 **MR. BELLO:** No redirect, Your Honor.
- 4 **JUDGE FREY:** Thank you. That's all the questions I have. Commission Staff.
- 5 **MR. BELLO:** Thank you. Your Honor, in closing, the Commission Staff believes
- 6 that it's met its burden of proving by documentary and testimonial evidence that
- 7 Tru Enterprise Corporation dba Car Crusher Inc of Louisiana violated the
- 8 Commission's General Order dated October 13, 2023 by failing to maintain
- 9 insurance on file with the Commission. As Ms. Burl indicated, Commission Staff
- is seeking that the company be found guilty of that violation, that Common Carrier
- 11 Certificate Number 8516 be cancelled, and that the carrier be ordered to pay a
- 12 citation fee in the amount of \$25.
- 13 **JUDGE FREY:** Thank you. And just for completeness, what legal authority
- permits cancellation of the carrier's certificate?
- 15 **MR. BELLO:** Your Honor, we have -- I believe the October 13, 2023 has that as
- well, and I am drawing a blank on which Title 45 provision it is, but is it 171 that
- authorizes the -- I'll have to look it up. I'd be happy to either brief that for you, or
- look it up quickly, if you'd allow me. I have my green book here, if you want, Your
- 19 Honor.
- 20 **JUDGE FREY:** I'll give you a moment to look it up, just so we have completeness
- 21 for the record.
- 22 MR. BELLO: Sure. Thank you, Judge. For the record, you can see I'm out of
- practice. I apologize, Your Honor, for the delay.

- 1 **JUDGE FREY:** No problem.
- 2 MR. BELLO: Your Honor, I believe it is the 2023 General Order, but if you would
- 3 allow me the time to provide additional information to the tribunal, I'd hate to
- 4 continue to waste your time. I know I can find the specific citation.
- 5 **JUDGE FREY:** If we want to just take a brief recess --
- 6 **MR. BELLO:** Sure. Thank you.
- 7 **JUDGE FREY:** -- then you can look without us being on the record. We'll just
- 8 take a brief recess. I'll be in my office, you can let me know.
- 9 **MR. BELLO:** Thank you, Judge.
- 10 **JUDGE FREY:** In the meantime, I will leave the original to Exhibit 5 right here,
- but we'll just take a brief recess.
- 12 **[OFF THE RECORD]**
- 13 [BACK ON THE RECORD]
- 14 **JUDGE FREY:** So we are back on the record for our transportation citation
- 15 hearings this morning. We had taken a brief recess in Docket Number T-37199.
- We are back on the record in Docket Number T-37199 Louisiana Public Service
- 17 Commission versus Tru Enterprise Corporation dba Car Crusher Inc of Louisiana.
- 18 We had taken a recess for Mr. Bello to locate the authority for cancellation of
- 19 authority for this carrier. And Mr. Bello?
- 20 MR. BELLO: Thank you, Your Honor. Justin Bello, again, on behalf of
- 21 Commission Staff. And I apologize, my time away from Transportation has left
- 22 me a little flat footed. The authority that we're relying on ultimately comes from
- 23 the Constitution, Article 4, Section 21, but the specific General Order that the

- 1 Commission Staff relies on for citing for insurance coverage is the October 13,
- 2 2023 General Order, Section 16 specifically.
- 3 **JUDGE FREY:** Okay. And Section 16 refers to if the Commission requests
- 4 insurance filings from a carrier and they fail to provide it; is that correct, Mr. Bello?
- 5 **MR. BELLO:** That is correct, Your Honor.
- 6 **JUDGE FREY:** So in this circumstance, we had a carrier -- I want to take a look
- 7 at it -- so Staff may seek cancellation of a carrier's authority after due notice in
- 8 hearing based on a carrier's failure to update insurance filings with the Commission
- 9 if the carrier's failed to update insurance filings within three years, or if the motor
- 10 carrier fails to update insurance filings based on Staff's request for updated filings
- 11 within three years from the date of the last insurance filing. So if this is the
- provision you're relying on, Mr. Bello, just please explain Paragraph 16 in relation
- 13 to the facts of the case in this matter.
- 14 **MR. BELLO:** Thank you, Your Honor. It's Commission Staff's position that by
- sending both the informal letters of Staff 2 and Staff 3, which are the cancellation
- letter and the tentative hearing letter, in both of those, we do request that they file
- 17 updated insurance with the Commission.
- 18 **JUDGE FREY:** Okay.
- 19 **MR. BELLO:** With Provision 16 allowing for cancellation when we request such.
- 20 **JUDGE FREY:** Okay. And what is the Staff's position with regard to the
- 21 applicability of Revised Statute 45:166 to the current proceedings?
- 22 **MR. BELLO:** I'd be happy to review that briefly, Your Honor. Thank you, Your
- Honor. We believe that Title 45:166 directly applies here because we have an

- 1 individual who is no longer in line with one of our rules and regulations, which is
- 2 to keep insurance on file with the Commission. Your Honor, if the cited carrier is
- 3 required to have insurance on file and they don't, we believe you can use Title
- 4 45:166 after due notice and a hearing to cancel a certificate.
- 5 **JUDGE FREY:** All right. Thank you, Mr. Bello. Does Staff have anything further
- 6 in this matter?
- 7 **MR. BELLO:** No, Your Honor. And thank you for your patience.
- 8 **JUDGE FREY:** Absolutely. If there's nothing further in this matter, this hearing
- 9 is adjourned. And that is all of the hearings I have on the docket for today.
- 10 **MR. BELLO:** Thank you, Judge.
- 11 **JUDGE FREY:** Is there anything further before we conclude today's
- 12 transportation hearings?
- 13 **MR. BELLO:** No, Your Honor.
- 14 **JUDGE FREY:** Thank you. If there's nothing further, these hearings are
- 15 adjourned.
