A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY IS HEREBY GRANTED TO <u>TIDAL LOGISTICS, INC.</u> whose office or place of business is at <u>FORT WORTH,</u> <u>TEXAS</u> authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF WASTE OVER IRREGULAR ROUTES.

Transportation of non-hazardous oilfield waste and hazardous waste over irregular routes, statewide with the following restrictions:

- 1. Restricted to the transportation of non-hazardous oilfield waste and oilfield waste deemed to be hazardous which originates north of a line drawn east and west across the State of Louisiana along the northern borders of Vernon, Rapides, Avoyelles and West Feliciana Parishes.
- 2. Select Energy Services, LLC ("Select") may use no more than a total of five (5) vacuum trucks at any given time under this authority.
- 3. Select may use no more than a total of use (2) dump trucks/trailers at any given time under this authority.
- 4. Restricted against the transportation of waste in roll-on/roll-off boxes.
- 5. Select will use no leased or owner/operator trucks under this authority.
