Docket No. T-37641, In re: Cancellation of Common Carrier Certificate Number 7057 for failure to file an Annual Report for 2024 and/or pay a late filing fee of \$500.00 and a citation fee of \$25.00 as required by General Order 2 dated July 1, 1921 and General Order dated March 18, 2021.¹

ORDER OF DISMISSAL

The Louisiana Public Service Commission ("Commission") issued a citation to Jamie Duff's Body & Frame, Inc. ("Carrier") on July 1, 2025, directing the Carrier to appear at a hearing on August 13, 2025. Notice of the proceeding was published in the Commission's *Official Bulletin* on July 3, 2025. The hearing was continued several times on motion of Commission Staff. On November 21, 2025, Commission Staff filed a *Motion to Dismiss*, requesting to dismiss this matter with prejudice and advising that Common Carrier Certificate No. 7057, was canceled by Order No. T-37728 issued November 17, 2025.

This dismissal is prepared in accordance with Rule 56(d) of the Rules of Practice and Procedure of the Commission, which provides:

Except at the discretion of the administrative law judge, the procedures contained within subpart (a) of this Rule shall not apply to a motion to dismiss jointly filed by all parties of record, a motion to dismiss with prejudice filed by the party who instituted the proceeding, or a motion to dismiss without prejudice filed by a party who instituted the proceeding but prior to the filing of any other party's filing of a responsive pleading. Upon the filing of such a motion to dismiss, the administrative law judge may forego all recommendation procedures and prepare an appropriate order of dismissal for issuance by the Commission.

IT IS THEREFORE ORDERED:

That Docket Number T-37641 is **DISMISSED** with prejudice.
