YOU ARE HEREBY NOTIFIED, COMMANDED AND REQUIRED to appear at a hearing on Thursday, January 11, 2023 at 9:30 a.m., before a Louisiana Public Service Commission Administrative Law Judge. The hearing will be held at the Louisiana Public Service Commission, Galvez Building, 11th Floor, 602 North 5th Street, Baton Rouge, Louisiana, 70802. Parking is available in the Galvez Parking Garage across from the Galvez Building on North Street.

TO SHOW CAUSE, if any, why you should not be found guilty by the Commission of violation of La. R.S. 45:161 through 180.1, by engaging in activities related to moving household goods prior to complying with the requirements of La. R.S. 45:164 (E) and General Order dated March 16, 2021 and for failure to comply with the requirements of General Order dated April 3, 2008 as amended; and for further order or orders as the Commission may deem necessary in the premises.

No later than fifteen (15) days before the date of the scheduled hearing, **any party** to this proceeding may request a **status conference** to discuss the issues herein. The request must be in writing and filed in the same manner as a request for continuance. At the hearing, the Commission Staff will present testimony and evidence in support of its allegations against you. You will be provided an opportunity to cross-examine Commission Staff's witness(es) and to present evidence and testimony in your defense. You will need to bring an original and four (4) copies of each document you wish to place into evidence.

Re: Advertising without LPSC authority

It has come to the attention of the Louisiana Public Service Commission ("LPSC") that Move Precision LLC is advertising at <http://moveprecision.com/> as well as on Instagram and Yelp, which reflects advertising for **local & long distance moving** with the phone number listed as (877)244-6968.

Move Precision LLC does not have the proper LPSC authority pursuant to General Order dated March 16, 2021 to offer household goods moving within the State of Louisiana and is therefore prohibited by the Commission's rules and regulations from advertising as such.

Pursuant to LPSC General Order dated April 03, 2008 all household goods carriers, operating intrastate in Louisiana, shall **include their legal and/or registered name, physical address and Louisiana Public Service Commission certificate number in all advertising, and said information shall also be included on all invoices and written bids or estimates given to consumers.**

This letter serves as a warning to cease advertising as a household goods mover and remove all advertising referencing household goods moving immediately. If your company wishes to perform household goods moves and advertise as such, please submit an application which can be found on our website www.lpsc.louisiana.gov or by calling (888) 342-5717 along with the proper fees no later than **October 1, 2023** to avoid receiving a citation from the LPSC.
