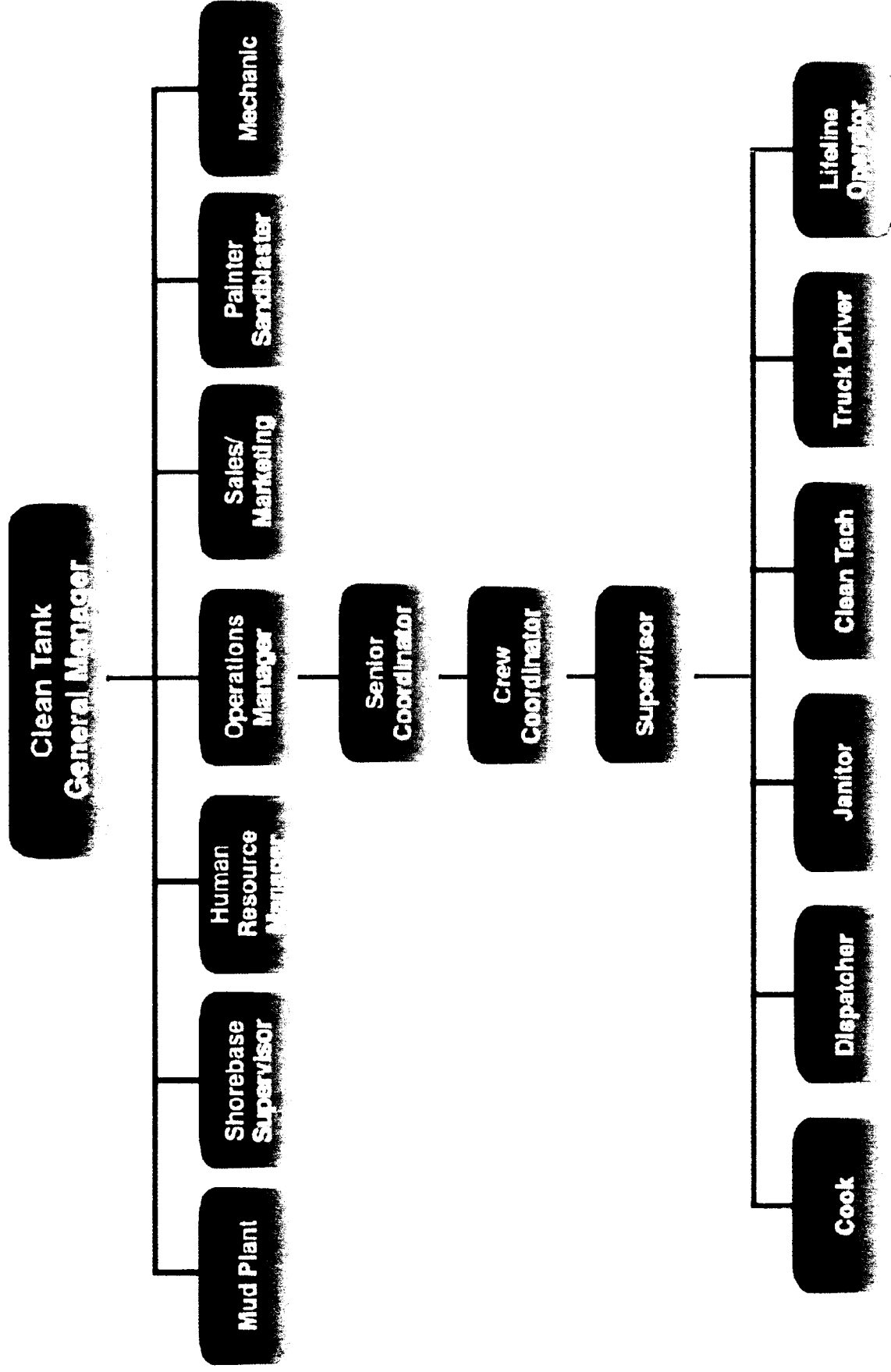

CONTRACT CARRIER PERMIT

NO. 1486

A PERMIT TO OPERATE IN LOUISIANA INFRASTATE COMMERCE AS A CONTRACT CARRIER BY MOTOR, SHAWING NOT MORE THAN FIVE PARCELS UNDER THE PROVISIONS OF TITLE 48 CHAPTER 4 OF THE REVISED STATUTES OF LOUISIANA HEREBY GRANTED TO CLEARSTAR, L.L.C., whose office or place of business is at 801 DEN MOULAY, LOUISIANA, to operate as follows:

Transportation under a Contract Carrier Permit with three named contracts for non-hazardous waste, restricted to the Parishes of LaFayette, Terrebonne, St. Mary and Washington. The three named shippers for the three contracts will be Gulfport Marine Services, L.L.C., Shell Offshore, Inc. and American Recovery, L.L.C.

Granted pursuant to Code No. 7-24597, dated May 14, 2008. Except for terms beyond control, non-operation of an authority for a period of six (6) months could lead to its annulment pursuant to La. R.S. 48:164, Paragraphs B and C.)

Said CLEARSTAR, L.L.C. shall so operate for parties authorized under electronic copies of what are to be filed with the Louisiana Public Service Commission, subject to rules and regulations of the Commission bearing thereon.
