### ***Notice of Non-Compliance***

Dear Ms. Garfinkel:

This letter is to advise that U.S. Telepacific Corp. ("Company"), is not in compliance with the Conditional Staff approval filed on July 31, 2025, which requires:

"The Commission has accepted the original pages of the tariff filed by the Company with an effective date of July 24, 2025, and an issued date of April 28, 2025. The tariff now on file in the Commission's Baton Rouge Office must be **modified** to reflect the effective and issue dates stated above. Please re-submit two (2) copies of the tariff reflecting this change within thirty (30) days of the date of this letter or by September 1, 2025."

As of the date of this letter, the Company has failed to file an updated tariff in Docket No. S-37664 pursuant to Staff's Conditional Approval. Given this failure to comply, Staff directs the Company to file into the record of this proceeding on or before March 16, 2026 their updated tariff. Failure to do so could result in Staff revoking its Conditional Approval, including revocation of U.S. TelePacific's Certificate of Authority.
