**REPORT OF STATUS CONFERENCE**

Deadline for the filing of pre-hearing briefs. The parties' briefs shall address, in the order presented in the Joint Pre-Hearing Statement, the remaining issues in dispute.


**Hearing.** A hearing in this proceeding will be convened at **10:00 A.M. on Monday, June 29, 2026 and continue as needed through Tuesday, June 30, 2026** in the 11<sup>th</sup> Floor Hearing Room of the Galvez Building, 602 North Fifth Street, Baton Rouge, Louisiana.

All parties intending to present evidence at the hearing shall bring a copy of each exhibit for the court reporter, as well as additional copies for the judge, the research attorney, and all other parties to the proceeding. *Hearing exhibits presented to the court reporter for admission into the hearing record shall be single-sided.*

Compliance with Rule 6 of the Commission's Rules of Practice and Procedure is required if the parties wish to proceed by stipulation. Accordingly, a contradictory hearing will not be converted, nor will an uncontested stipulation hearing be scheduled, until the parties have complied with Rule 6.
