The Tribunal issued a Notice of Assignment and Notice of Initial Status Conference on May 8, 2018, which scheduled a status conference for May 21, 2018. The Notice specifically stated that ELL's Petition would be addressed at the status conference.

On May 9, 2018, applicants South Alexander Development I, LLC, South Alexander Development II, LLC, South Alexander Development III, LLC, South Alexander Development IV, LLC, South Alexander Development V, LLC, South Alexander Development VI, LLC, South Alexander Development VII, LLC, South Alexander Development VIII, LLC, South Alexander Development IX, LLC, South Alexander Development X, LLC, South Alexander Development XI, LLC, and South Alexander Development XII, LLC (collectively, "Applicants") filed an Unopposed Motion to Continue Status Conference. *Inter alia*, the Applicants' Motion represented that neither the Applicants nor the Louisiana Public Service Commission Staff object to ELL's Petition.

**HAVING CONSIDERED** the foregoing;

**IT IS HEREBY ORDERED** that ELL's Petition is **granted**. ELL is hereby granted full intervenor status, and shall be placed on the Official Service List and served with all pleadings, notices, and orders.
