In cases where applications for the transfer of Transportation certificates and permits are unopposed after expiration of the publication period and the Staff is satisfied that the transferor has operated the authority pursuant to requirements of LRS 45:166b and that the transferee is ready, fit and able to operate the authority, the authority shall be transferred after expedited hearing and the appropriate filings being made. Likewise, uncontested applications for Transportation certificates and permits will also be approved after expedited hearing and the staff is satisfied that the record after hearing does reveal that a prima facie case of fitness has been shown.
