**UNOPPOSED MOTION TO CONTINUE STATUS CONFERENCE**

NOW COMES, through undersigned counsel, the Louisiana Public Service Commission Staff (“Staff”), which respectfully requests that the video status conference scheduled in this matter for Wednesday, June 30, 2021, at 10:00 a.m. be continued until Thursday, July 22, 2021, at 10:00 a.m. In support of this Unopposed Motion to Continue Status Conference, Staff represents and submits the following:

1.

On May 25, 2021, Utilities, Inc. of Louisiana (“UIL”) filed with the Louisiana Public Service Commission (“Commission”) a Request for Extension of Formula Rate Plan with Modification Thereto (“Request”).

2.

Notice of UIL’s Request was published in the Commission’s Official Bulletin No. 1246 dated May 28, 2021.

3.

The period for timely interventions and protests in this matter by interested parties expired on June 14, 2021. No interventions were filed.

4.

On June 16, 2021, the Tribunal issued a Notice of Assignment and Notice of Video Status Conference in this matter, which gave notice that a status conference in this proceeding had been scheduled for Wednesday, June 30, 2021, at 10:00 a.m.

5.

On June 21, 2021, the Commission issued Request for Proposals (“RFP”) 21-17 for an outside consultant to assist Staff in this matter.

6.

Staff anticipates that the Commission will consider and vote upon the bid(s) submitted in response to RFP 21-17 at its Business and Executive Session to be held on July 14, 2021.

7.

Staff wishes to consult with the outside consultant to be selected by the Commission prior to the setting and establishment of a procedural schedule in this matter.

8.

Staff has contacted Mrs. Kara B. Kantrow, counsel for UIL, and Mrs. Kantrow has indicated that UIL has no opposition to this Unopposed Motion to Continue Status Conference.

9.


Staff and UIL also give notice that the parties are amenable to a status conference in person in this proceeding, if it pleases the Tribunal.

Staff avers that the continuance of the status conference scheduled in this matter will not cause any harm or prejudice to known parties in interest. No other parties have intervened in this matter; thus, no other known parties will be adversely impacted if the status conference scheduled in this matter is continued.
