Parking is available in the Galvez Parking Garage across from the Galvez Building on North Street. **Furthermore, a citation fee in the amount of \$25.00 has been assessed to your LPSC account.**

Dear Carrier:

Last November, we forwarded you a blank form to be used in filing your **2019** Annual Report with the Commission. The notarized report was due in this office on or before 120 days after the end of your fiscal year which would be **January 28, 2020**; however, the report has not yet been received. **A late fee of \$500.00 has been assessed to your account.** A blank copy of the Annual Report may be found on our website under the "Motor Carriers" tab.

You have tentatively been scheduled to appear at a hearing October 27th, 28th or 29th, 2020 at a time to be determined, before a Louisiana Public Service Commission Administrative Law Judge to show cause why an order should not be issued by the Commission canceling your authority for failure to timely file your Annual Report as required by General Order 2 dated July 1, 1921 and General Order dated April 23, 2001 amended June 19, 2012.

If BOTH the ANNUAL REPORT and FIVE HUNDRED DOLLAR (\$500.00) late fee are not received by **August 20, 2020** the Commission will proceed to issue a citation to appear at the above mentioned hearing and a TWENTY FIVE DOLLAR (\$25.00) citation fee will be assessed.

Furthermore, pending filing of the report and/or late fee, no applications, tariffs, leases or other filings will be accepted, and no vehicle identification stamps or cab cards will be issued.
