**SUBMISSION OF PROOF OF PUBLICATIONS**

NOW BEFORE the Louisiana Public Service Commission (hereinafter referred to as the “**Commission**” or “**LPSC**”), through undersigned counsel, comes South Louisiana Electric Cooperative Association (hereinafter referred to as “**SLECA**” or “**Cooperative**”), who avers as follows:

1.

SLECA, a Louisiana nonprofit cooperative corporation organized under La. R.S. 12:401 *et seq.*, provides electric service in the following parishes in Louisiana: Assumption, Lafourche, St. Martin, St. Mary, and Terrebonne.

2.

On May 21, 2025, in accordance with the requirements of LPSC Order No. U-36339, SLECA filed its Formula Rate Plan (“**FRP**”) 2024 Annual Report (“**Annual Report**”) with the Commission, which is based on the test year period ending December 31, 2024, and was calculated in accordance with the appropriate Formula Rate Plan Rider Schedule and associated attachments. Pursuant to the provisions of the Louisiana Constitution, Article IV, Section 21, when a public utility files a proposed rate schedule which could result in a change in rates, it is required to give notice of such application by publication in the official state journal and in the official journal of each parish within the geographic area in which the schedule would become applicable and effective.

3.

Accordingly, after the filing of the Annual Report, SLECA caused to be published in the official journals of each of the parishes described above and in the official state journal the notice of filing of the Annual Report.
