After review of the record, the Louisiana Public Service Commission Staff ("Commission") Staff ("Staff") states that the following actions have occurred in the above-referenced docket:

1. The application submitted by CBTS Technology Solutions LLC, CBTS Borrower, LLC, and Cincinnati Bell Inc. providing notice of the transfer of ownership and indirect control of CBTS Technology to CBTS Borrower, LLC. was filed on March 20, 2024.

- 2. Notice of the filing was published in the Commission's Official Bulletin No. 1320 dated on March 28, 2024.
- 3. The fifteen (15) day intervention period expired without intervention or protest on April 12, 2024.
- 4. Staff detected no compliance issues involving the parties to the proposed transfer.
