ORDER NO. T-37358-Corrected - 5/27/2026 - Louisiana Public Service Commission vs. Move Precision LLC. In re: Alleged violation of Order T-37019 for failure to comply to the Affidavit and Stipulation executed on May 1, 2024. Order No. T-37358 (Corrected) accepts the Recommendation of the Administrative Law Judge and finds that Move Precision LLC is guilty of violating Commission Order No. T-37019 dated June 18, 2024, for failing to comply with the terms of the Affidavit and Stipulation accepted therein; orders Move Precision LLC to pay a \$25.00 citation fee; and, orders Commission Staff to report to La.
