A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY IS HEREBY GRANTED TO <u>STRIKE CONSTRUCTION, LLC</u> whose office or place of business is at <u>SPRING, TEXAS</u> authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF SPECIAL COMMODITIES OVER IRREGULAR ROUTES handling the following described commodities, in the territories described, and in accordance with the following limitations:

- 1. Restricted to the transportation of non-hazardous oilfield waste which originates north of a line drawn east to west across the State of Louisiana along the northern borders of Vernon, Rapides, Avoyelles, and West Feliciana Parishes.
- 2. Restricted against the transportation of non-hazardous industrial solid waste and hazardous waste.
- 3. Restricted to the use of no more than ten (10) power units total, in any combination of: roll-on/roll-offs, end dumps and/or dump trailers.
- 4. Restricted to the use of no more than ten (10) vacuum trucks.
- 5. Strike Construction agrees that it will file no application to amend or expand this certificate for a period of two (2) years from the date of issuance of the LPSC Order issued in this matter.

(Issued pursuant to Order No. T-32182, dated April 26, 2013. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C.)

Said **STRIKE CONSTRUCTION, LLC** shall perform such operations under tariffs now or hereafter filed with the Commission and in compliance with all laws and rules and regulations of the Commission bearing thereon.
