If BOTH the ANNUAL REPORT and FIVE HUNDRED DOLLAR (\$500.00) late fee are not received by <u>March 3, 2021</u> the Commission will proceed to issue a citation to appear at the above mentioned hearing and a TWENTY FIVE DOLLAR (\$25.00) citation fee will be assessed.

Furthermore, pending filing of the report and/or late fee, no applications, tariffs, leases or other filings will be accepted, and no vehicle identification stamps or cab cards will be issued.
