AFFIDAVIT AND STIPULATION

I, DEBRAHAT MCDUFFIE, whose title or position is President

of Fast Affordable College Student Movers, Inc. ("Fast Affordable"), and who is authorized to enter into this agreement on behalf of Fast Affordable herein admit that Fast Affordable violated the following: 1) General Order dated July 12, 2013 by failing to provide a written estimate prior to conducting moving services and 2) General Order dated July 01, 2021 as amended by exceeding rates as outlined in the company's tariff dated June 27, 2013, while operating under Common Carrier Certificate number 7823, allegedly having occurred on or about October 18, 2021 through October 20, 2021. As a result, Fast Affordable agrees to the imposition of a \$7,000.00 fine with \$3,500.00 of the fine suspended conditioned on the following:

1. Fast Affordable College Student Movers, Inc. not being found guilty, entering a plea of guilty, or entering a plea of no contest to any of the rules and regulations of the Commission relative to household goods movers for a period of one year from the date of this executed

Affidavit and Stipulation, for a total fine of \$3,500.00 to be paid in two (2) installments along with a \$25.00 citation fee.

2. Remit the first installment of the fine and fees of \$1762.50 by May 20, 2022 and the second installment of \$1762.50 on or before June 1, 2022;
3. Agree to refund the excess charges in the amount of \$1,187.37 for moving services paid by the customer on October 18-20, 2021. Such refund will be paid in certified funds to the customer, Mrs. Brenda Primeaux, and mailed to the customer using priority P.O. Box 236 OR 165 Bertie Jeane Road Evans, Louisiana 70639, on or before May 26, 2022;
4. Agree to provide the LPSC proof of the aforementioned refund, totaling \$1,187.37, on or before May 26, 2022;
5. Agree that the company shall follow the Commission's rules and regulations regarding the providing of estimates for regulated house hold goods moving services pursuant to the Commission's General Order dated July 12, 2013 and adhering to the rates as outlined in the company's tariff dated June 27, 2013 pursuant to General Order dated July 01, 1921 as amended and;
6. Remit all payments due in certified funds by the dates described herein and deliver this executed stipulated agreement to the LPSC office by **Wednesday, June 1, 2022.**

I understand that failure to comply with any of the above will result in the \$3,500.00 suspended becoming due immediately. I waive an appearance at a hearing on the citation.




