CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY
AS A COMMON CARRIER OF SPECIAL COMMODITIES
OVER IRREGULAR ROUTES

(Cancels 7291 & 7534)

A CERTIFICATE IS HEREBY GRANTED TO SOUTHERN SPECIALTIES TRANSPORTATION, LLC whose office or place of business is at CHURCH POINT, LOUISIANA authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF WASTE OVER IRREGULAR ROUTES.

Transportation of non-hazardous oilfield waste as follows:

- A. Non-hazardous oilfield waste which originates in the parishes of Acadia, Evangeline, St. Landry, Jefferson Davis, Vermilion, and Cameron.
- B. Transportation of non-hazardous oilfield waste which originates north of a line drawn east and west across the northern borders of Vernon, Rapides, Avoyelles, and West Feliciana Parishes shall be restricted as follows:

Carrier may use no more than a total of ten (10) vacuum trucks at any time under this authority, with no more than five (5) of the ten (10) being owner-operator trucks at any time, and no more than a total of ten (10) roll-on/roll-offs or end dumps at any time under this authority, with no more than five (5) of the ten (10) being owner-operator trucks at any time; and

Carrier agrees that no application for additional or expanded authority shall be filed for a period of two (2) years from the original date of issuance (April 13, 2010) of Common Carrier Certificate No. 7534 to JTH Transportation, LLC.

- C. Restricted against the transportation by dump trucks of regulated nonhazardous solid waste originating in the parishes of St. John the Baptist, St. Charles, and St. James with restriction being applicable only to the transportation on non-hazardous solid waste in dump trucks.

(Reissued pursuant to S-32071 for a merger of certificate 7534 dated Apr. 13, 2010 originally issued pursuant to T-31172 and certificate 7291 dated Nov. 27, 2007 originally issued pursuant to T-29541 and pursuant to L.R.S. 45:164 and the rules and regulations of the Louisiana Public Service Commission. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C.)

Said SOUTHERN SPECIALTIES TRANSPORTATION, LLC shall perform such operations under tariffs now or hereafter filed with the Commission and in compliance with all laws and rules and regulations of the Commission bearing thereon.
