Parking is available in the Galvez Parking Garage across from the Galvez Building on North Street. *Furthermore, a citation fee in the amount of \$25.00 has been assessed to your LPSC account.*

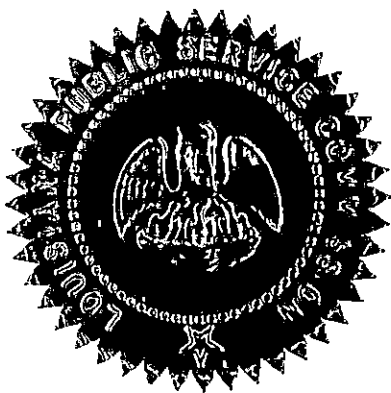



If BOTH the ANNUAL REPORT and FIVE HUNDRED DOLLAR (\$500.00) late fee are not received by June 16, 2021 the Commission will proceed to issue a citation to appear at the above mentioned hearing and a TWENTY FIVE DOLLAR (\$25.00) citation fee will be assessed.

Furthermore, pending filing of the report and/or late fee, no applications, tariffs, leases or other filings will be accepted, and no vehicle identification stamps or cab cards will be issued.
