YOU ARE HEREBY NOTIFIED, COMMANDED AND REQUIRED to appear at a hearing on Thursday, August 26, 2021 at 9:30 a.m., before a Louisiana Public Service Commission Administrative Law Judge. The hearing will be held at the Louisiana Public Service Commission, Galvez Building, 11th Floor, 602 North 5th Street, Baton Rouge, Louisiana, 70802. Parking is available in the Galvez Parking Garage across from the Galvez Building on North Street. Furthermore, a citation fee in the amount of \$25.00 has been assessed to your LPSC account.

TO SHOW CAUSE, if any you have or can, why an order should not be issued by the Commission canceling your Common Carrier Certificate Numbers 8281 and 8260 for failure to file an Annual Report for 2020 and/or pay a late filing fee of \$500.00 and a citation fee of \$25.00 as required by General Order 2 dated July 1, 1921 and General Order dated March 18, 2021; and for further order or orders as the Commission may deem necessary in the premises.

At the hearing, the Commission Staff will present testimony and evidence in support of its allegations against you. PLEASE BE ADVISED that any requests to reschedule this hearing will be considered if the request meets the following four (4) requirements:


1. One original and two copies of the request must be mailed, hand delivered or faxed to the Commission's Records and Recordings Division at the following address:

The notarized report was due in this office on or before April 30th of this year; however, the report has not been received or was received late. <u>A late fee of \$500.00 has been assessed to your account</u>. A blank copy of the Annual Report may be found on our website under the "Motor Carriers" tab.

You have tentatively been scheduled to appear at a hearing August 25 or 26, 2021 at 9:30 a.m., before a Louisiana Public Service Commission Administrative Law Judge to show cause why an order should not be issued by the Commission canceling your authority for failure to timely file your Annual Report as required by General Order 2 dated July 1, 1921 and General Order dated April 23, 2001 amended June 19, 2012.

If BOTH the ANNUAL REPORT and FIVE HUNDRED DOLLAR (\$500.00) late fee are not received by <u>June 16, 2021</u> the Commission will proceed to issue a citation to appear at the above mentioned hearing and a TWENTY FIVE DOLLAR (\$25.00) citation fee will be assessed.

Furthermore, pending filing of the report and/or late fee, no applications, tariffs, leases or other filings will be accepted, and no vehicle identification stamps or cab cards will be issued.
