Any party seeking a continuance of the hearing date must file a motion for the continuance by **January 25, 2021**. The motion must also contain a statement (1) affirming that the moving party has contacted all other parties to the case concerning the proposed continuance and (2) advising of the position of each of the other parties to the proposed continuance. Motions for continuance filed after this date will be considered only upon a showing of good cause for the delay.
