

RE: Insurance

Your **Common Carrier Certificate Number 7394** has been flagged for failure to maintain the required insurance coverage on file with the Commission. In accordance with the Commission's General Order dated January 12, 1976, intrastate carriers must maintain proof of the required insurance coverage on file at the Commission at all times. Should the carrier fail to maintain such filings, the Commission may pursuant to La. R.S. 45:166, revoke the carrier's certificate.

- On February 14, 2022 the Commission received a Form K showing a cancellation date of March 20, 2022. A letter was mailed to your company on March 25, 2022, requesting a new Form E filing. As of the date of this letter, a *new Form E for Commercial Auto Liability Insurance* has not yet been received.

**You have tentatively been scheduled to appear at a hearing on Thursday, August 4, 2022 at 9:30 a.m.,** before a Louisiana Public Service Commission Administrative Law Judge to show cause why an order should not be issued by the Commission canceling your **Common Carrier Certificate Number 7394** for failure to maintain the required insurance coverage on file with the Commission, and for further order or orders as the Commission may deem necessary in the premises.

If the required insurance coverage is not received by **May 14, 2022**, the Commission will proceed to issue a citation where Commission Staff will present testimony and evidence in support of its allegations against you. Once your company is cited a **TWENTY FIVE DOLLAR (\$25.00)** citation fee will be assessed. If you have any questions regarding this matter, please contact our office at (225) 342-1424.


