CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY
AS A COMMON CARRIER OF SPECIAL COMMODITIES
OVER IRREGULAR ROUTES

NO. 7846

A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY IS HEREBY GRANTED TO **S & A TRUCKING, LLC** whose office or place of business is at **LOTTIE, LOUISIANA** authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER of special commodities over irregular routes by motor, handling the following described commodities, in the territories described, and in accordance with the following limitations:

1. Restricted to the transportation of non-hazardous oilfield waste which originates in Point Coupee, West Feliciana, East Feliciana, St. Helena, East Baton Rouge, West Baton Rouge, Evangeline, Iberville, Livingston, Ascension and Beauregard Parishes, and the parishes located north of a line drawn east and west across the State of Louisiana along the northern borders of Vernon, Rapides, Avoyelles, and West Feliciana Parishes.
2. When transporting non-hazardous oilfield waste originating north of a line drawn east and west across the State of Louisiana along the northern borders of Vernon, Rapides, Avoyelles and West Feliciana Parishes, S&A Trucking may use no more than five (5) vacuum trucks.
3. When transporting non-hazardous oilfield waste originating in Point Coupee, West Feliciana, East Feliciana, St. Helena, East Baton Rouge, West Baton Rouge, Evangeline, Iberville, Livingston, Ascension and Beauregard Parishes, S&A Trucking may use no more than one (1) vacuum truck.
4. S&A Trucking, LLC will use no leased or owner/operator trucks under this certificate.
5. Transportation by dump trucks of regulated non-hazardous solid waste shall not be allowed when the waste originates in the parishes of St. John the Baptist, St. Charles, and St. James.
6. S&A Trucking, LLC agrees that it will file no application to amend or expand this certificate for a period of two (2) years from the date of issuance of the LPSC Order issued in this matter.

(Issued pursuant to Order No. T-32048, dated October 17, 2013 and corrected October 29, 2013. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C.)

Said **S & A TRUCKING, LLC** shall perform such operations under tariffs now or hereafter filed with the Commission and in compliance with all laws and rules and regulations of the Commission bearing thereon.
