The purpose for this Limited Company is to engage in any lawful activity for which limited liability companies may be formed under the Limited Liability Company Law of Louisiana.

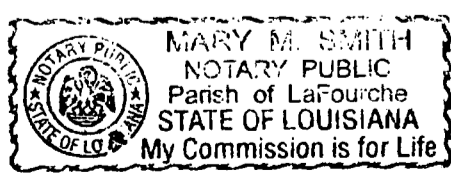
