A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY IS HEREBY GRANTED TO G. L. SIMMONS, INC. whose office or place of business is at <u>DEVILLE</u>, <u>LOUISIANA</u> authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER of special commodities over irregular routes by motor, handling the following described commodities, in the territories described, and in accordance with the following limitations:

- 1. Restricted to the transportation of non-hazardous oilfield waste and any oilfield waste deemed to be hazardous, which originates in the parishes of Allen, Evangeline, St. Landry, Vernon, Rapides, Avoyelles, Winn, Concordia, Catahoula, Tensas, Franklin, Caldwell, La Salle, Grant, Natchitoches, and Sabine, when transporting waste generated from an oil spill, a closed looped system, a drill mud reserve pit, and the cleaning of oil filed vessels.
- 2. GL Simmons may use no more than a total of three (3) power units (vacuum trucks/ dump trailers) at any given time.
- 3. GL Simmons will use no leased or owner/operator trucks under this certificate.
- 4. GL Simmons agrees that no application for additional or expanded authority shall be filed for a period of two (2) years from the date of issuance of the Common Carrier Certificate in this proceeding.
