PosiGen of Louisiana, LLC ("PosiGen"), pursuant to Rule 10 of the Louisiana Public Service Commission ("LPSC") Rules of Practice and Procedures, hereby intervenes in the above captioned docket to participate as a party therein.

I.

This proceeding was initiated by the LPSC to review the LPSC's Net Energy Metering ("NEM") policies currently being utilized for small scale residential and commercial solar energy installations. Notice of this proceeding was republished in the LPSC's Official Bulletin Number 1105 dated January 1, 2016. Interventions are due on or before January 21, 2016.
