A PERMIT TO OPERATE IN LOUISIANA INTRASTATE COMMERCE AS A CONTRACT CARRIER BY MOTOR, SERVING NOT MORE THAN FIVE PARTIES UNDER THE PROVISIONS OF TITLE 45 CHAPTER 4 OF THE REVISED STATUTES OF 1950, IS HEREBY GRANTED TO <u>DUPRE' LOGISTICS</u>, <u>LLC</u> whose office or place of business is at LAFAYETTE, LOUISIANA, to operate as follows:

Transportation of Calcium Chloride, Mud/Slurry waste over irregular routes, statewide

Restricted to transportation of the following:

Transportation in vacuum trucks from oil well sites for disposal is prohibited.

Restricted to a Contract Carrier Permit for transportation of Calcium Chloride, Mud/Slurry for one named shipper, Honeywell International Inc. and its subsidiaries thereof.

(Reissued pursuant to S-34266 for a name change from Dupre' Transport, LLC originally issued pursuant to Order No. T-29158 dated March 8, 2006. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C.)

Said <u>DUPRE' LOGISTICS</u>, <u>LLC</u> shall so operate for parties authorized under contracts copies of which are to be filed with the Louisiana Public Service Commission, subject to rules and regulations of the Commission bearing thereon.
