I hope you and your family enjoyed the Thanksgiving holiday. I'm reaching out to inform you of a couple of important items as we head into December:

- Your November 2023 invoice will include an increase in the Fuel Charge due to a higher Current Coal Price ("CCP") for the month of November. The Mississippi River remains at/near record low levels since September, and as a result, Cleco Cajun has been in Force Majeure with its logistics provider since late September. This ongoing Force Majeure has increased the cost for delivered tons for the current invoice period.
- 2. Also, Cleco Cajun has executed a purchase and sale agreement with Atlas Capital Holdings for the Cleco Cajun portfolio the link below will bring you to the 8-K filing made yesterday. We remain business as usual here at Cleco Cajun and we anticipate the transaction to Close in Q2 2024.
