YOU ARE HEREBY NOTIFIED, COMMANDED AND REQUIRED to appear at a hearing on Thursday, March 7, 2024 at 9:30 a.m., before a Louisiana Public Service Commission Administrative Law Judge. The hearing will be held at the Louisiana Public Service Commission, Galvez Building, 11th Floor, 602 North 5th Street, Baton Rouge, Louisiana, 70802. Parking is available in the Galvez Parking Garage across from the Galvez Building on North Street.

TO SHOW CAUSE, if any, why you should not be found guilty by the Commission of violation of La. R.S. 45:161 through 180.1, by engaging in activities related to moving household goods prior to complying with the requirements of La. R.S. 45:164 (E) and General Order dated March 16, 2021 and for failure to comply with the requirements of General Order dated April 3, 2008 as amended; and for further order or orders as the Commission may deem necessary in the premises.

No later than fifteen (15) days before the date of the scheduled hearing, **any party** to this proceeding may request a **status conference** to discuss the issues herein. The request must be in writing and filed in the same manner as a request for continuance. At the hearing, the Commission Staff will present testimony and evidence in support of its allegations against you. You will be provided an opportunity to cross-examine Commission Staff's witness(es) and to present evidence and testimony in your defense. I contracted with Benson to move me from Uptown to Bayou St John. We used them over 2 days, loading one day and unloading the next day. Before the move, I asked if they would wrap my furniture and was told "yes" they would. I also stressed that my couch was very heavy and was very expensive. Upon loading day, the couch and the bed frame would not fit in the truck so we arranged with Benson to unload then run back to my place in Uptown to pick up the couch and bed. No problem and they were happy to do this. The wrapping of the couch was very minimal, but since they had done a good job with the rest of the pieces (heavy large furniture they moved fairly easily), I did not worry.

When they brought the couch into my new home, it was snagged on the front. I pointed this out the movers, owner was not present, and they of course had no idea how this happened. I assured them this was not present before they loaded the truck.

I was contacted by the owner an hour or so later for payment, and I paid them in good faith, as they did move me and I am not a difficult person to work with. I told the owner that they had snagged my couch and he asked me to text him photos and promised to call me back when he got back to the

office. This was on Thursday, 5/31/18. I did as requested. I did not hear back from him so on Monday night, 6/4/18, I texted him and asked why he had not called me. He immediately texted back indicating he would call back the next day. He called back Tuesday afternoon, 6/5/18. He indicated that he needed to come look at the couch. I informed him that after several hours of work, I was able to repair most of it by pushing the snag back into the couch, but it was still not "fixed" like new and if he wanted to come look at it that was fine with me. I told him how I fixed it and then he proceeded to tell me that that's how he would fix it. Then he asked if he could call me back. That was Tuesday, 6/5/18, and here it is Saturday 6/9/18 and I have not heard a thing from these people.

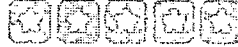
