COMES NOW, U.S. TelePacific Corp. ("Applicant") FEIN Number 95-4593876 and respectfully requests the Louisiana Public Service Commission grant a Certificate of Authority to provide competitive Local Exchange Services and Interexchange services on a resold basis and to additionally include such authority to include Voice over Internet Protocol (VoIP) and also Interexchange Services on a resold basis.

In accordance with Section 301(F) of the Louisiana Public Services Commission's Regulations for Competition in the Local Telecommunications Market, Applicant states the following:

The Applicant has been in business for over 25 years providing unique telecommunications products and services to business customers on a nationwide basis.

The company designs powerful, flexible, secure, and highly scalable voice, data, Internet and integrated communication services for businesses nationwide. Additionally, they are able to bundle products and services of multiple trusted vendors and providers increasing their ability to solve business problems.

U.S. TelePacific Corp. helps businesses and organizations nationwide leverage critical changes in telecommunication technology to increase productivity, reduce operating costs, and protect the bottom line. U.S. TelePacific Corp. offers, scalable and innovative solutions when it comes to Voice, Data, Networking, Coloration Tools and Cloud Solutions designed

specifically for a customer's industry and customized for their business.

As a Competitive Carrier (CLEC) in multiple states U.S. TelePacific Corp. bundles and resells the products and services of Tier 1 and Tier 2 Carriers, using a combination of their own facilities and predominantly the underlying service provider all while offering the business customer competitive prices.

Headquartered in Austin Texas, the U.S. TelePacific Corp. team is comprised of telecom veterans with broad industry experience designing and deploying Smart Solutions for companies with a single location or organizations with a regional or national footprint that drive business value and keep productivity moving.

Applicant has the managerial, technical and leadership capabilities to provide the telecommunications services for which it seeks authority under this application. The Applicant has a well-grounded and well-rounded management and technical team who have been long term employees of the Applicant. Management and leadership foster innovation, creativity and collaboration amongst not only themselves but also the employee base.

Management and technical biographies of key personnel are included in the submission with the original filing as an exhibit.

(a) To demonstrate the financial ability, each applicant shall provide a copy of its most recent stockholders annual report and its most recent SEC 10K, or, if the applicant is not publically traded, its most recent financial statements. If the applicant does not have separate financial reports, it may submit applicable financial statements of an affiliate with explanation to demonstrate the financial ability of applicant.

Applicant is financially qualified to provide the telecommunications services for which it seeks the authority requested in this Application attached as Exhibit C. Applicant is providing financial statements represented as Income Statement and Balance Sheet to demonstrate Applicant's financial wherewithal. Applicant requests that these financials provided be kept strictly confidential and to be used for internal Commission use only. In the event the Commission was to make these financial statements available to the public it would cause due harm to Applicant. Therefore, Applicant requests that these financials be treated as Confidential and filed under seal.

(b) To demonstrate managerial ability, each applicant shall attach a brief description of its history providing telecommunications services and shall list the geographic areas in which is has been and is currently providing telecommunications services. Newly created applicants shall list the experience of each principal officer in order to show its ability to provide service.

Applicant has the managerial, technical, administrative and operational qualifications necessary to provide the proposed services throughout the state of Louisiana as its proposed service territory. As noted above, Applicant operates a national communications company which provides multiple communications products and services. The Applicant is currently providing service as a registered CLEC, VoIP Provider and/or both (where and as required by Commission regulations) as registered entity with the proper Secretary of State in the states of: California (CLEC, IXC and VoIP), Florida (VoIP), Nevada (CMRS, VoIP), New Jersey (VoIP), New York (VoIP), South

Carolina (VoIP), Texas (VoIP), DC (VoIP) and Washington State (VoIP) and additional states. Applicant is in full compliance with each state Commission as appropriate where registrations require such state Commission compliance.

The Applicant currently has CCN and/or applications pending in other states with other Public Service or Public Utility Commission at this time. The Company is a going concern and as the business grows, the Company will seek to file appropriate commission certifications on a state by state (case by case) basis.

The Applicant has never had a request for authorization denied by any commission.

The Applicant has never had authorization revoked in any state by any commission.

Set forth in **Exhibit D** are resumes or key management personnel who are responsible for the Applicant's operations. These resumes highlight management's extensive and long historical background in the telecommunications industry. The management team members and leadership team have extensive years of telecommunications expertise. Applicant thereby demonstrates that it possesses significant managerial and technical experience and expertise along with all qualifications necessary to operate a competitive telecommunications company in Louisiana, which is fully consistent with the Commission's requirement. In fact Applicant exceeds Commission requirements and proudly stands ready to serve the needs of business class customers throughout the state.

(c) Technical Ability shall be indicated by description of the applicant's experience in providing telecommunications services or in the case of newly created companies, the applicant may provide other documentation which supports its technical ability.

Applicant intends to offer a wide array of telecommunications products and services on a

resold basis throughout the state of Louisiana as noted in Exhibit F as Applicant's representative coverage map. Applicant shall provide services to business customers only and will not offer residential services of any kind. Applicant proposes to provide resold local exchange services to business class customers throughout the state of Louisiana. Specifically, the Applicant wishes to provide business class subscribers with local dial tone and with hosted iPPBX communications systems provisioned over VoIP technology. The hosted IPPBX phone systems that Applicant wishes to offer can interface with Cable Modem, ATA, Router, Ethernet, MPLS, Point to Point, Private Line and other forms of delivery which the Applicant will make available to business customers.

As demonstrated in Exhibit E the Applicant proposes to incorporate by reference all services areas of the Incumbent Local Exchange Carriers and its underlying carriers where competition has been approved by the Commission. Further the applicant shall also include with its service offerings access to emergency services, operator services, directory assistance, interexchange service and other ancillary features that Applicant must provide pursuant to applicant statutes and regulations. Applicant intends to rely upon the facilities and network equipment deployed by its underlying carriers as the Incumbent Local Exchange Carriers, Applicants designated additional underlying providers in conjunction with Applicants network infrastructure.

Applicant will also provide on a resold basis Plain Old Telephone Lines (POTS), direct private line, data private line and Point to Point Service.

Applicant attests that it shall comply with all applicable rules and regulations of the Commission related to service areas.
