OVER IRREGULAR ROUTES**

A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY IS HEREBY GRANTED TO SERVICE CONSULTING & MANAGEMENT, LLC whose office or place of business is at BREAUX BRIDGE, LOUISIANA authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF SPECIAL COMMODITIES OVER IRREGULAR ROUTES by motor, handling the following described commodities, in territories described:

Transportation of non-hazardous oilfield waste; statewide in vacuum trucks and (80) barrel bob-tail units, should be granted with the following restrictions:

1. Restricted to the transportation of non-hazardous oilfield waste in six (6) company owned vacuum trucks and unlimited bobtail units;
2. Restricted against the use of roll-on / roll-offs trucks and dump trucks;
3. SCM will use no leased or owner/operator trucks under this authority;
4. SCM agrees that no other terminals south of I-10 and west of Breaux Bridge shall be established; and
5. SCM agrees that no application for additional or expanded authority shall be filed for a period of two (2) years from the date of issuance of the common carrier certificate to SCM in this proceeding.

(Reissued pursuant to Order S-32305 for a name change from Service Consulting & Management, Ltd., previously issued pursuant to Order No. T-31943. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C.)

Said SERVICE CONSULTING & MANAGEMENT, LLC shall perform such operations under tariffs now or hereafter filed with the Commission and in compliance with all laws and rules and regulations of the Commission bearing thereon.
