**You have tentatively been scheduled to appear at a hearing August 25 or 26, 2021 at 9:30 a.m. ,** before a Louisiana Public Service Commission Administrative Law Judge to show cause why an order should not be issued by the Commission canceling your authority for failure to timely file your Annual Report as required by General Order 2 dated July 1, 1921 and General Order dated April 23, 2001 amended June 19, 2012.

If BOTH the ANNUAL REPORT and FIVE HUNDRED DOLLAR (\$500.00) late fee are not received by **June 16, 2021** the Commission will proceed to issue a citation to appear at the above mentioned hearing and a TWENTY FIVE DOLLAR (\$25.00) citation fee will be assessed.

Furthermore, pending filing of the report and/or late fee, no applications, tariffs, leases or other filings will be accepted, and no vehicle identification stamps or cab cards will be issued.
