



RE: Insurance

Your **Registration & Insurance Number 1510** has been flagged for failure to maintain the required insurance coverage on file with the Commission. In accordance with the Commission's General Order dated January 12, 1976, intrastate carriers must maintain proof of the required insurance coverage on file at the Commission at all times. Should the carrier fail to maintain such filings, the Commission may pursuant to La. R.S. 45:166, revoke the carrier's certificate.

- On April 14, 2020 the Commission received a request for Suspension of Authority, which was approved through July 14, 2020. On June 22, 2020 a second request for Suspension of Authority was received and approved through January 14, 2021. As of January 15, 2021, a *new Form E for Commercial Auto Liability Insurance* has not yet been received.

**You have tentatively been scheduled to appear at a hearing on Thursday, April 1, 2021 at 9:30 a.m.**, before a Louisiana Public Service Commission Administrative Law Judge to show cause why an order should not be issued by the Commission canceling your **Registration & Insurance Number 1510** for failure to maintain the required insurance coverage on file with the Commission; and for further order or orders as the Commission may deem necessary in the premises.

If the required insurance coverage is not received by **February 12, 2021**, the Commission will proceed to issue a citation where Commission Staff will present testimony and evidence in support of its allegations against you.
