**CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY
AS A COMMON CARRIER OF SPECIAL COMMODITIES
OVER IRREGULAR ROUTES**

NO. 7291

A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY IS HEREBY GRANTED TO SOUTHERN SPECIALTIES TRANSPORTATION, LLC whose office or place of business is at **CHURCH POINT, LOUISIANA** authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF SPECIAL COMMODITIES OVER IRREGULAR ROUTES by motor, handling with the following limitations and / or restrictions:

Southern Specialties Transportation, LLC be granted a common carrier certificate authorizing the transportation of drilling mud for disposal, which originates in the parishes of Acadia, Evangeline, St. Landry, Jefferson Davis, Vermilion, and Cameron.

Restricted against the transportation by dump trucks of regulated non-hazardous solid waste originating in the parishes of St. John the Baptist, St. Charles, and St. James with restriction being applicable only to the transportation on non-hazardous solid waste in dump trucks.

(Issued pursuant to Corrected Order No. T-29541 dated November 26, 2007 and issued pursuant to L.R.S. 45:164 including Paragraph A and the rules and regulations of the Louisiana Public Service Commission. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C.)

Said **SOUTHERN SPECIALTIES TRANSPORTATION, LLC** shall perform such operations under tariffs now or hereafter filed with the Commission and in compliance with all laws and rules and regulations of the Commission bearing thereon.

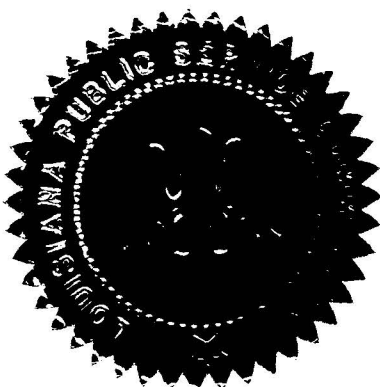
