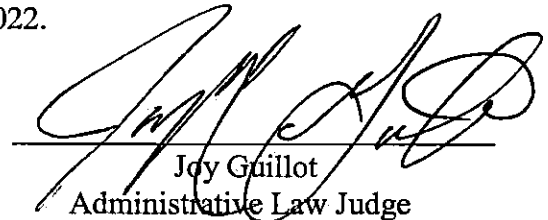
On August 30, 2022, the Alliance for Affordable Energy filed a Petition to Intervene and Request for Inclusion on Service List ("Petition").
