

BE IT KNOWN that on this 28th day of June, 2007,

BEFORE ME, **DANIEL A. CAVELL**, a Notary Public duly commissioned and qualified in and for the aforesaid parish and state, and in the presence of the undersigned witnesses, personally came and appeared:

NEIL L. ARABIE (SS# xxx-xx-6121) and JERRY LEBLANC ARABIE (SS# xxx-xx-9992), who declared to me Notary that they have been married but once and then to each other, residents of the Parish of Lafourche, State of Louisiana, whose present mailing address is 156 St. Peter Road, Thibodaux, Louisiana.

who, acting under the authority of Louisiana's Limited Liability Company Law, do enter into the following contract for the formation of a Limited Liability Company and adopt the following Articles of Organization:

- NAME The name of the Limited Liability Company shall be ONSHORE MATERIALS, L.L.C., sometimes hereafter called the "Company".
- PURPOSES The company's purpose is to engage in any lawful activity for which Limited Liability Companies may be formed under the Louisiana Limited Liability Company Law.
- 3. **DURATION** Unless dissolved earlier by law or agreement, the existence of the Company will be perpetual.
 - 4. MANAGEMENT The company shall be managed by Managers.

The first Managers shall be:

NEIL L. ARABIE and JERRY LEBLANC ARABIE 156 St. Peter Road, Thibodaux, Louisiana 70301.

5. NO RESTRICTIONS - There shall be no restrictions on the authority of the company's members to bind the company beyond those required by law and/or the operating agreement.

- 6. LIABILITY WAIVER AND INDEMNIFICATION No member shall have any liability for damages for any duty breached or activity performed in connection with the management of the company. Further, each member shall be fully indemnified by the company for any judgments, settlements, penalties, fines or expenses incurred because he or she is or was a member of the company. It is the intention of this provision to afford members of the company the most complete elimination of liability and the fullest rights to indemnification possible under the laws of the State of Louisiana and particularly Title 12, Section 1315 of the Revised Statutes of Louisiana and this provision shall be so construed.
- 7. Unless and until an amendment to these articles by authentic act providing otherwise is filed in the office of the Louisiana Secretary of State and in each parish in which ONSHORE MATERIALS, L.L.C. owns immovable property, any person dealing with ONSHORE MATERIALS, L.L.C., may rely upon a certificate of Neil L. Arabie OR JERRY LEBLANC ARABIE to:
 - a) establish the membership of any member of the company,
 - establish the authenticity of any records of the company or
 - establish the authority of any person to act on behalf of **ONSHORE MATERIALS**, L.L.C., including but not limited to the authority to take actions referred to in Louisiana Revised Statutes Title 12, Section 1318 (B), which actions include:
 - (1) The dissolution and winding up of the company,
 - (2) The sale, exchange, lease, mortgage, pledge, or other transfers of all of substantially all of the assets of the company,
 - (3) The merger or consolidation of the company,
 - (4) The incurrence of indebtedness by the company other than in the ordinary course of its business,
 - (5) The alienation, lease or encumbrance of any immovables of the company, and
 - (6) An amendment to the articles of organization.






