COMES NOW, In-Telecom Consulting, LLC ("Applicant") and respectfully requests the Louisiana Public Service Commission grant a Certificate of Authority to provide competitive Local Exchange Services on a resold basis and to additionally include such authority to include Voice over Internet Protocol (VoIP) and also Interexchange Services on a resold basis.

In accordance with Section 301(F) of the Louisiana Public Services Commission's Regulations for Competition in the Local Telecommunications Market, Applicant states the following:

Applicant has no direct Affiliated entities which that are sometimes designated as wholly owned subsidiaries or other companies that are separate but hold some sort of common affiliation or ownership with another entity.

telecommunications services for which it seeks authority under this application. The Applicant has a

well rounded and diverse management and technical team. All key personnel have been long term

employees of the Applicant. Management and leadership promote creativity and all the while foster

innovation and collaboration amongst not only themselves but across all areas of the Company.

In the event the Commission was to make these financial statements available to the public it would cause due harm to Applicant. Therefore Applicant requests that these financials be treated as Confidential and filed under seal.

(b) To demonstrate managerial ability, each applicant shall attach a brief description of its history providing telecommunications services and shall list the geographic areas in which is has been and is currently providing telecommunications services. Newly created applicants shall list the experience of each principal officer in order to show its ability to provide service.

Applicant has the managerial, technical, administrative and operational qualifications necessary to provide the proposed services throughout the state of Louisiana as its proposed service territory. As noted above, Applicant operates a unique and structured communications company which provides multiple communications products and services. The Applicant is currently providing service as a VoIP Provider in the states of: GA, OK, TX and discloses under and as pursuant to Section 301(E)(10).

. Applicant is in full compliance with each state Commission as appropriate where registrations require such state Commission compliance.

The Applicant currently has no other CCN and/or applications pending in any other state with any other Public Service or Public Utility Commission at this time. However because the Company is a going concern and as the business grows, the Company will seek to file appropriate commission certifications on a state by state (case by case) basis.

The Applicant has never had a request for authorization denied by any commission.

The Applicant has never had authorization revoked in any state by any commission.

Applicant intends to offer an array of telecommunications products and services on a resold basis throughout the state of Louisiana as noted in <u>Exhibit E</u> as Applicant's representative coverage map that include VoIP, Local Exchange, Interexchange and also Fiber and Internet based services. Applicant shall provide services to business customers only and will not offer residential services of any kind. Applicant proposes to provide resold local exchange, interexchange and VoIP services to business class customers throughout the state of Louisiana. Specifically, the Applicant wishes to provide business class subscribers with hosted iPPBX communications systems provisioned over VoIP technology. The hosted IPPBX phone systems that Applicant wishes to offer can interface with Cable Modem, ATA, Router, Ethernet, MPLS, Point to Point, Private Line and other forms of delivery which the Applicant will make available to business customers.

As demonstrated in <u>Exhibit E</u> the Applicant proposes to incorporate by reference all services areas of the Incumbent Local Exchange Carriers and its underlying carriers where competition has

been approved by the Commission. Further the applicant shall also include with its service offerings access to emergency services, operator services, directory assistance, interexchange service and other ancillary features that Applicant must provide pursuant to applicant statutes and regulations. Applicant intends to rely upon the facilities and network equipment deployed by its underlying carriers as the Incumbent Local Exchange Carriers, Applicants designated additional underlying providers in conjunction with Applicants network infrastructure.

Applicant will also provide on a resold basis Plain Old Telephone Lines (POTS), direct private line, data private line and Point to Point Service.

Applicant attests that it shall comply with all applicable rules and regulations of the Commission related to service areas.
