**A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY IS HEREBY GRANTED TO STAFFORD TRANSPORT OF LOUISIANA, INC. DBA CEI whose office or place of business is at WALKER, LOUISIANA authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF WASTE OVER IRREGULAR ROUTES.**

Transportation of hazardous and non-hazardous waste, except oilfield waste, statewide.

Restricted against the transportation of all commodities to or from oilfield drilling sites, oilfield production facilities and oilfield service companies, including but not limited to salt water, brine water, liquid mud, oil well completion fluids and oilfield waste.

Transportation of chemical waste; from, and to, all points within the State of Louisiana, in dump trucks, dump trailers, detachable roll-on/roll-off dump boxes and floats.

(Reissued pursuant to Order S-32216 for a name change to add the dba of "CEI" originally issued pursuant to Order No. T-31854, dated January 20, 2012 for a sale and transfer from Custom Ecology, Inc. dba CEI. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C.)

Said **STAFFORD TRANSPORT OF LOUISIANA, INC. DBA CEI** shall perform such operations under tariffs now or hereafter filed with the Commission and in compliance with all laws and rules and regulations of the Commission bearing thereon.
