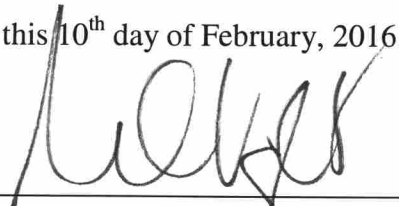

Having considered the *Motion for Late Intervention and Inclusion on Service List* filed by Gulf South Solar, the motion is **granted**.

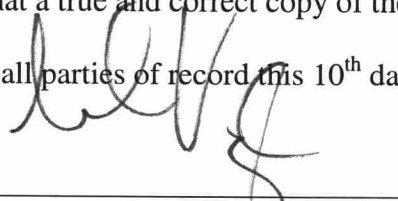
