The hearing will be held at the Louisiana Public Service Commission, Galvez Building, 11th Floor, 602 North 5th Street, Baton Rouge, Louisiana, 70802. Parking is available in the Galvez Parking Garage across from the Galvez Building on North Street. *Furthermore, a citation fee in the amount of \$25.00 has been assessed to your LPSC account.*

TO SHOW CAUSE, if any you have, why an order should not be issued by the Commission canceling your **Common Carrier Certificate Number 6943** for failure to obtain 2021 vehicle identification stamps and register vehicles and drivers for 2021 as required by General Order dated April 25, 2012 and La. 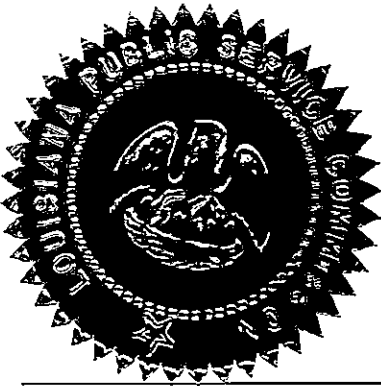
PLEASE BE ADVISED that any requests to reschedule this hearing will be considered if the request meets the following four (4) requirements:

1. One original and two copies of the request must be mailed, hand delivered or faxed to the Commission's Records and Recordings Division at the following address:



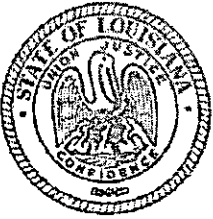

Upon audit of your file it was noted that you did not purchase identification stamps, register your vehicles and register your drivers for 2021. If this was an oversight on your part; please mail the **VEHICLE & DRIVER forms** with payments to our office before **May 14, 2021** to avoid a citation. If you are cited you will be assessed a \$25 citation fee and scheduled to appear at a hearing before a Louisiana Public Service Commission Administrative Law Judge to show cause why an order should not be issued by the Commission **CANCELING YOUR AUTHORITY** for failure to obtain annual vehicle identification stamps and register your drivers with the Commission; and for further order or orders as the Commission may deem necessary in the premises.

Every vehicle operated as a Common or Contract Carrier of Passengers or a Dispatch Taxicab Carrier subject to LPSC jurisdiction shall be required to register each driver and provide vehicles information each year (and when vehicles are added to the fleet), including age, model, type, and quality and pay a fee of \$10 per vehicle as established by General Order dated April 25, 2012. *Once a vehicle is registered with the Louisiana Public Service Commission (LPSC) it will be the responsibility of the Business Entity to cancel any vehicles that are removed from its fleet or give notice for any vehicles that are taken out of service temporarily. ^ **BUSINESS ENTITIES LOCATED/OPERATED IN THE PARISHES OF JEFFERSON, ORLEANS, PLAQUEMINE, ST. BERNARD, ST. CHARLES, ST. JOHN, AND ST. TAMMANY MAY NOT OPERATE ANY VEHICLE WHEN THE MODEL YEAR OF THE VEHICLE IS GREATER THAN SEVEN (7) YEARS OLD, UNLESS IT HAS BEEN PRE-APPROVED FOR AN EXEMPTION. CALL THE MAIN OFFICE FOR EXEMPTIONS PROCEDURES.** Pursuant to La. R.S. 45:164 (A), any vehicle with a reconstructed title as provided for in La. R.S. 32:707 or an equivalent title issued pursuant to the laws of another state in the operation of such business is prohibited from being utilized under this LPSC authority.
