

APPLICATION FOR ADJUSTMENT IN TAP FEES

NOW BEFORE THE COMMISSION, through undersigned counsel, comes L & R Utilities, Inc. (hereinafter referred to as "L & R" or "the Company"), who in support of its application for an adjustment in its tap fees avers as follows:

BACKGROUND

1.

L & R a Louisiana corporation, is a for-profit public utility providing safe and reliable water service to approximately 877 residential customers and 5 commercial customers and wastewater service to approximately 783 residential customers and 32 commercial customers in Ouachita Parish, State of Louisiana.

2.

L & R's current water tap fee is \$450, which includes labor, meter and materials. A water tap requires three workers, a supervisor and two laborers, in two trucks along with a track hoe. Including the time to perform the water tap, to load and unload equipment and materials, and the travel to and from the location takes approximately half a day. Half a day of labor for three workers, two trucks and a track hoe is a substantial amount of resources devoted to each water tap. L & R estimates that hiring a third-party contractor to perform the water taps would likely cost approximately \$2,000 plus materials. The costs of the meter and materials required to perform a water tap are shown in the attached Exhibit 1. For a typical residential customer 3/4 inch connection, the current cost for the meter is \$295.88 and the materials are \$501.02 for a total of

\$796.90. At L & R current water tap rates, the meter and materials alone exceed the tap fee by \$346.90.

3.

Tap fees only affect new customers, not existing customers. Tap fees are a cost of construction of a new building/home. L & R respectfully submits that the tap fees should reflect the actual cost of construction. At the current tap fee rates, L & R and its current customers are inappropriately subsidizing the cost of construction of new buildings/homes. This diverts needed funds from other areas of L & R's operations to subsidize the new customer tap costs.

4.

L & R is requesting that its water tap fee be adjusted to \$650 plus the cost of the meter and materials. Meter and material costs are subject to variation and may change frequently. By separating this portion of the tap fee from the labor/administrative component it protects the customer and L & R by ensuring that the customer pays only the actual cost of the meter and materials, no more and no less. This is the same tap fee currently charged by another water utility in L & R's service area, People's of Bastrop ("POB"). L & R respectfully submits that this is a reasonable and fair water tap fee.

5.

L & R's current wastewater tap fee is \$400. In a typical year, L & R performs only a couple of wastewater taps. Developers typically put in wastewater taps when they construct a neighborhood. However, if a building/home is added later this can necessitate a new wastewater tap. When wastewater taps are performed L & R tends to hire a third-party contractor to complete the work. This is because the sewer lines are typically located deep underground.

6.

L & R is requesting that its sewer tap fee be adjusted to provide for “Contractor’s cost plus 10%”. Before performing a sewer tap L & R obtains several bids from contractors and goes with the lowest qualifying bid. While L & R does not perform the installation of the sewer tap, L & R does perform all the administrative work associated with the sewer tap, including: L & R receives the request from the new customer for the sewer tap; then L & R contacts several contractors and provides them the scope of work and location; L & R coordinates with the contractor and, to the extent necessary, with the new customer for the construction bid to be prepared; L & R notifies the customer of the cost of the sewer tap fee and collects the payment; L & R then notifies the winning contractor and contracts with them; L & R coordinates with the contractor until the work is complete; L & R verifies the work is complete and satisfactory; and then L & R processes the contractor’s invoice and issues payment. L & R submits that 10% of contractor’s cost is a reasonable amount reflecting the administrative burden and resources associated with the sewer tap.

PROPOSED TARIFF

7.

Attached hereto as Exhibits 2 & 3 are the proposed tariffs with the requested tap fees for systems owned by L & R. The tariffs illustrating the current tap fees are attached hereto as Exhibits 4 & 5. L & R respectfully submits that the proposed tap fee adjustments are necessary to cover the actual cost of the water and sewer taps, and are fair and reasonable.


It is respectfully requested that Notice of this filing be published in the Commission's Official Bulletin, to be dated June 7, 2024.





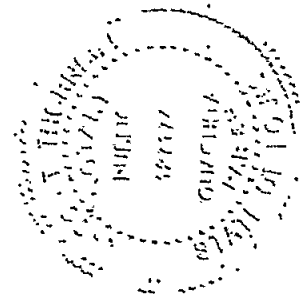
