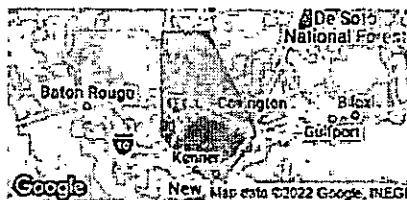

We did not have a good experience with them. Called to book move date and time with prices explained and truck fee taken. This was at least 2 weeks before our move date. The day before our move date called to re-confirm and all was set.

Then things change, day of move came more than 1 & 1/2 hours late. Guys show up and start working quickly, then one leaves who is the supervisor leaving the other 3. Now the 3 guys are barely moving, taking many breaks, talking on their phones and not getting the work done. Had to call their supervisor many times over the course of the day to keep things semi-moving but they were just milking the clock. What should have been a 4 hour move ended up being 6 & 1/2 hours. (For reference it took 3 guys to unload our move and put together furniture in December only 3 hours.) Additionally, our bed frame/ base was damaged and they will not send us the claim form after requesting it several times.

Overall, not the best workers, no time management and damages.

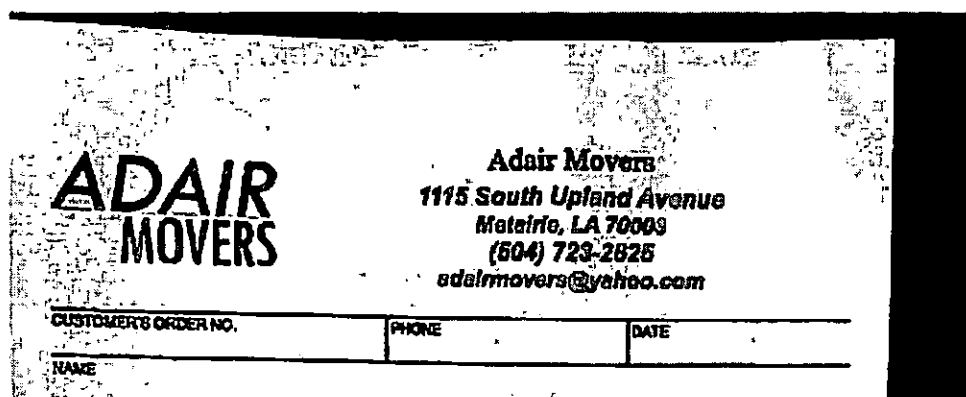

Mr. Adair,

As per our conversation on Tuesday, February 22, 2022, I have spoken to my Supervisor, Tammy Burl, concerning the complaint we have on file for your company, Adair Movers, LLC. I informed her that you stated that you were not going to continue to perform household good moves and that you stated that you do not own a truck. Even if you do not own a truck and use rental trucks, you still have to have authority with the Commission in order to provide household good moving services within Louisiana. My Supervisor will be out of the office until next Thursday and upon her return, we will discuss your complaint further to see if she wants to draft a notarized affidavit for you to sign stating that you, Herman Adair dba Adair Movers, LLC understand the following:

1. Adair Movers LLC must obtain Louisiana Public Service Commission (LPSC) authority prior to either advertising or operating as a household goods mover, as that term is defined in the LPSC's rules and regulations.
2. Adair Movers LLC will not operate as a household goods mover intrastate in Louisiana until such time as Adair Movers obtains LPSC authority to operate as a household goods mover.
3. Adair Movers LLC agrees to remove all advertising for household good moving services, including but not limited to, advertising on Yelp and Facebook. And remove any reference to offering household goods moving services, immediately.
4. If Adair Movers LLC should fail to remove all advertising which references offering regulated household goods moving services, a citation will be issued by the LPSC to Adair Movers LLC.

Please let me know if you are going to apply for the necessary authority to perform household goods moving services or you are going to be removing all advertisements and are willing to execute and sign the aforementioned notarized affidavit. I am attaching a copy of the LPSC Household Good Application. If you have any questions, please feel free to contact me. I am also attaching another copy of the LPSC Household Good Application for you.
