


Your **Common Carrier Certificate Number 8056** has been flagged for failure to maintain the required insurance coverage on file with the Commission. In accordance with the Commission's General Order dated May 17, 2004, intrastate carriers of Household Goods must maintain proof of the required insurance coverage on file at the Commission at all times. Should the carrier fail to maintain such filings, the Commission may pursuant to La. R.S. 45:166, revoke the carrier's certificate.

- On July 08, 2021, the Commission received Surety Bond Continuation Certificate showing a cancellation date of March 30, 2022 for your Surety Bond policy. A letter was mailed to your company on April 01, 2022, requesting a new Surety Bond Continuation Certificate. As of May 16, 2022, a **new Surety Bond Continuation Certificate** has not yet been received.
- On May 19, 2021, the Commission received an Acord Certificate showing a cancellation date of April 06, 2022 for your Workman's Compensation policy. A letter was mailed to your company on April 08, 2022, requesting a new Acord Certificate of Insurance. As of May 16, 2022, a **new Acord Certificate of Insurance** has not yet been received.

You have tentatively been scheduled to appear at a hearing on **Thursday, August 4, 2022** at 9:30 a.m., before a Louisiana Public Service Commission Administrative Law Judge to show cause why an order should not be issued by the Commission canceling your **Common Carrier Certificate Number 8056** for failure to maintain the required insurance coverage on file with the Commission; and for further order or orders as the Commission may deem necessary in the premises.

If the required insurance coverage is not received by **May 31, 2022**, the Commission will proceed to issue a citation where Commission Staff will present testimony and evidence in support of its allegations against you. Once your company is cited a TWENTY FIVE DOLLAR (\$25.00) citation fee will be assessed. If you have any questions regarding this matter please contact our office at (225) 342-1424.


