Docket No. T-37429, In re: Cancellation of Common Carrier Certificate No. 6360-B for failure to obtain 2024 vehicle identification stamps, as required by La. R.S. 45:161 through 180.1 and to pay a citation fee of \$25.00.

ORDER OF DISMISSAL

The Louisiana Public Service Commission (“Commission”) issued a citation to Donnie Plunk’s Towing & Recovery, Inc. (“Carrier”) dated November 18, 2024, directing the Carrier to appear at a show cause hearing on January 9, 2025. Notice of the proceeding was published in the Commission’s *Official Bulletin* on November 22, 2024. On December 13, 2024, the Commission Staff filed a *Motion to Dismiss* moving to dismiss this matter with prejudice advising that Common Carrier Certificate No. 6360-B was canceled by *Special Order 93-2024* on December 10, 2024.

This dismissal is prepared in accordance with Rule 56(d) of the Rules of Practice and Procedure of the Commission, which provides:

Except at the discretion of the administrative law judge, the procedures contained within subpart (a) of this Rule shall not apply to a motion to dismiss jointly filed by all parties of record, a motion to dismiss with prejudice filed by the party who instituted the proceeding, or a motion to dismiss without prejudice filed by a party who instituted the proceeding but prior to the filing of any other party’s filing of a responsive pleading. Upon the filing of such a motion to dismiss, the administrative law judge may forego all recommendation procedures and prepare an appropriate order of dismissal for issuance by the Commission.

IT IS THEREFORE ORDERED:

That Docket Number T-37429 is DISMISSED with prejudice.
