After review of the record, the Louisiana Public Service Commission Staff ("Staff") states that the following actions have occurred in the above-referenced docket:


- (1) The application submitted by Securus Technologies, LLC. ("Securus" or the "Company") was filed on June 4, 2025 providing notice of the transfer of indirect control of Securus.
- (2) Notice of the filing was published in the Commission's Official Bulletin No. 1351 on June 6, 2025.
- (3) The fifteen (15) day intervention period in this docket expired without intervention or protest on June 23, 2025.
- (4) Staff detected no compliance issues involving the parties to the proposed transaction.

This letter is to acknowledge that Staff has reviewed the above-docketed matter. Additionally, at present there are no outstanding compliance issues involving the Company.
