**REPORT
OF INITIAL VIDEO STATUS CONFERENCE**

A video status conference was convened in this proceeding on December 20, 2021 before Administrative Law Judge (“ALJ”) Steve Kabel. Remotely participating in the video status conference were:

Paul Guarisco and Brook Villa, on behalf of Connect Holding, LLC, Lumen Technologies, Inc., CenturyLink of Louisiana, LLC, CenturyTel of South Arkansas, Inc., and CenturyTel Broadband Services, LLC (collectively, “Joint Applicants”);

Rob Rieger and Taylor LeDuff, on behalf of intervenor Charter Fiberlink LA-CCO, LLC (“Charter Fiberlink”); and


Arvind Viswanathan, on behalf of the Louisiana Public Service Commission (“Commission”) Staff.

Mr. Guarisco provided an overview of the Joint Applicants’ application, and indicated that the Joint Applicants are working with the other parties to resolve the proceeding amicably. Mr. Rieger confirmed Charter Fiberlink’s efforts to arrive at an amicable resolution, and proposed a follow-up status conference. Mr. Guarisco further stated that the Joint Applicants reserve all rights pursuant to the Commission’s Rules of Practice and Procedure, including the right to file motions, the right to move to strike Charter Fiberlink’s intervention, and the right to request a status conference or the setting of a procedural schedule should the parties fail to arrive at an agreement. After additional discussion, the ALJ scheduled a follow-up status conference for Thursday, January 13, 2022. Accordingly,
